#### Ninth meeting of the Ad hoc Open-ended Working Group on Access and Benefit-Sharing

The first session of the ninth meeting of the Ad Hoc Open-ended Working Group on Access and Benefit-sharing (WGABS 9) was held in Cali, Colombia from 22-28 March 2010, with over 500 participants attending. The meeting was opened by the ABS Co-Chairs Timothy Hodges and Fernando Casas, followed by statements by Yadir Salazar, Ministry of Foreign Affairs of Colombia; Jochen Flasbarth, on behalf of the COP-9 President; Ahmed Djoghlaif, CBD Executive Secretary; U.N. Secretary General (via video message); and Carlos Martin-Novella, UNEP. The meeting continued the negotiation of the international regime on ABS, with a focus on consolidation of all operational text developed at the seventh and eighth meetings of the Working Group. The Working Group adopted a draft protocol proposed by the Co-Chairs as a basis for further negotiations. The draft is found in Annex I to the meeting report. The delegates agreed to suspend the meeting and resume the ninth meeting in June/July 2010 with the financial support of the Government of Japan. *(Cont'd on page 3)*

#### Visit to Toyooka, Hyogo Prefecture and Tokyo

At the kind invitation of the Mayor of Toyooka, the CBD Executive Secretary visited Toyooka City, Hyogo Prefecture, Japan in early March. A field visit was arranged to visit the Homeland Oriental White Storks breeding and rehabilitation center. While in Japan, the United Nations Information Centre (UNIC) and CBD organized a seminar on the International Year of Biodiversity in which the CBD Executive Secretary addressed and delivered a presentation on “Biodiversity Challenges and Responses: the Road to Nagoya and Beyond” to the Ambassadors accredited to Tokyo, the representatives of the U.N, member companies of Global Compact and media. In conjunction with the seminar, the signing ceremony of MoU between CBD and ITTO was organized (see page 4). A meeting was held with senior officials from the Ministry of Foreign Affairs, headed by the Ambassador of COP10, His Excellency Mr. Araki, together with the Directors in charge of COP 10. The CBD Executive Secretary also met with senior officials from the Ministry of the Environment, including the Vice Minister of Environment, His Excellency Mr. Tajima. Issues discussed included: ABS, COP 10, and the closing ceremony of IYB. A meeting was also held with the Parliamentary Secretary for Agriculture, Her Excellency Ms. Yasue Funayama, to discuss COP-MOP 5. The Executive Secretary also met Diet Members’ League for Promoting Environmental Policies in Partnership with NGOs to exchange views about the role of parliamentarians for biodiversity.



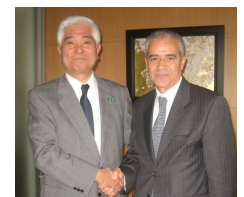

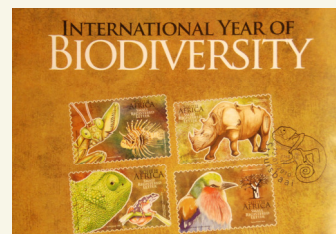

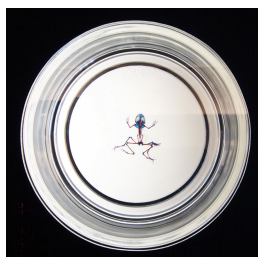

Prior to the first session of the WGABS-9 meeting, a Co-Chairs Open-ended Informal Consultation (CIIC) was convened to identify concrete solutions in order to facilitate and accelerate the negotiations at the ninth meeting of the Working Group. A meeting of ILC negotiators was also convened prior to the WGABS 9 meeting, thanks to the support from the Government of Spain, which brought together representatives from the seven geo-cultural regions (as recognized by the UNPFII) for detailed texted based discussions to allow ILCs to effectively participate in the ABS process.

In the margins of the ABS-9 meeting, special events were organized to mark the International Year of Biodiversity and to celebrate the World Water Day.

discussed included: preparations for ABS-9 meeting; update on the UNGA high level event in September 2010 and the Nagoya Biodiversity meetings; and CBD implementation of the outcome of the UNFCCC COP-15. The meeting discussed a number of issues, including: the draft strategic plan (2011-2020) of the Cartagena Protocol on Biosafety and the proposed framework for the second assessment and review process. 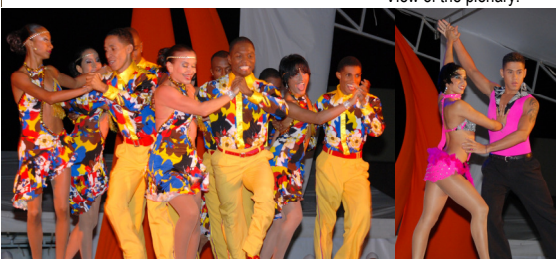

**Regional consultations for African countries back-to-back with African Minister Conference on ABS Windhoek, Namibia**

Pursuant to paragraphs 17 and 22 of COP Decision IX/12 on access and benefit sharing, the regional consultation for African countries took place on 4-6 March 2010, in Windhoek, Namibia, through the generous financial support of the Government of Denmark, and in close collaboration between the ABS Capacity Development Initiative for Africa which is implemented by the Deutsche Gesellschaft für Zusammenarbeit GmbH. The consultation provided an opportunity for the participants from the region to consult and exchange views on the components of the international regime during the intersessional period with a view to finalizing the negotiations of the international regime at the WGABS-9 meeting.

The consultation also allowed participants to prepare for the African Minister Conference on ABS on 8-10 March. Hosted by the Government of Namibia and the African Ministerial

Council on the Environment (AMCEN), the objective of the meeting was to prepare African leaders and their negotiators for the final decision-making on access and benefit sharing and the COP-10 high level segment. The conference was opened by President Hifikepunye Pohamba of Namibia, who delivered opening remarks at the start of the event. Statements were also delivered by: Honourable Rejoice Mabudafhasi, Deputy Minister of the Environment of South Africa, Chair of the African Ministerial Conference on the Environment (AMCEN) and Head of the Network on Women and Biodiversity; Honourable Netumbo Nandi-Ndaitwah, the Minister of Environment and Tourism of Namibia; and Honourable Karen Ellemann, the Danish Minister for the Environment. The meeting, which saw the participation of African leaders and high-level officials from more than 43 countries, is the last opportunity for ministers from African countries to bring their efforts together to ensure that the international regime responds to the needs of Africa and its people and that all efforts are made to ensure the adoption of the international regime at the tenth meeting of the Conference of the Parties.

**CBD AND ITTO PARTNERSHIP**

The secretariats of the Convention on Biological Diversity (CBD) and the International Tropical Timber Organization (ITTO) signed an agreement to closely collaborate over the coming four years. The Memorandum of Understanding aims at facilitating the implementation of activities linked to conservation and sustainable use of tropical forest biodiversity within the ITTO Biennial work programme 2010-2011 and subsequent work programmes, the ITTO Thematic Programmes, the ITTO Action Plan 2008-2011 and any successor Action Plan; and the CBD work programme on forest biodiversity in the context of the new CBD Strategic Plan and multi-year programme of work.

**World Water Day**



To mark World Water Day and highlight the linkages between biodiversity and clean water, the Secretariat of the Convention on Biological Diversity (CBD) released *Water, Wetlands and Forests: A Review of Ecological, Economic and Policy Linkages*. Produced in collaboration with the Secretariat of the Ramsar Convention on Wetlands and other partners, the report aims to foster better awareness of the crucial role that forests and wetlands play in sustaining the availability and quality of water critical for human well-being. It is geared towards enabling policy makers to be more aware of these ecosystems when formulating policies and management practices for water supply, supplements.

This year's World Water Day is being celebrated under the theme of "Clean Water for a Healthy World". The theme is intimately linked with year-long celebrations of the International Year of Biodiversity (IYB), which calls upon citizens to reflect on the role of biodiversity in providing for human well-being. During the IYB, the 65th session of the United Nations General Assembly will hold a high level session on biodiversity.

At the invitation of the Consulate of Tunisia in Montreal, the Secretariat participated in the third session of the International Discussion Forum 2010 (FID) on 21 March 2010 in Montreal, Canada.

Young people aged 20 to 30 years of various nationalities were present to discuss issues that concern the youth around the world, particularly with regards to the environment. The Secretariat gave a presentation and joined the discussions on the importance of education and of engaging the youth in the global biodiversity agenda.

All three sessions of the FID were designed for the youth to discuss the horizons for a better future and the goal of the forum was to come out with proposals that reflect the needs of young people whatever their origins or interests. The concerns of young people from around the world will be transcribed and made available for discussion in the International Pact for Youth which will be drafted after the forthcoming UN youth summit to

## World Urban forum 2010 - Rio de Janeiro, Brazil



On 22-26 March 2010, UN-HABITAT and the Government of Brazil hosted the fifth session of the World Urban Forum in Rio de Janeiro, under the theme “The right to the City - bridging the urban divide”.

The theme coincides with the recent report on the State of the World Cities 2010/2011: Bridging the Urban Divide, in which UN-Habitat estimates that a total of 227 million people in the world have moved out of slum conditions since 2000, meaning governments have collectively surpassed the Millennium Development target of moving people out of poverty by 2.2 times.

The Secretariat held an exhibition booth presenting the activities of the Global Partnership on Cities and Biodiversity, took part in dialogues on “Sustainable urbanisation: Cities in a Changing Climate” and sessions on resilience, adaptation and mitigation and in several of the events related to climate change and urban environment. A keynote statement by the CBD Executive Secretary was delivered at the LAB Advisory Committee meeting and ICLEI networking event (available at: <http://www.cbd.int/doc/speech/2010/sp-2010-03-24-rio-en.pdf>) on 24 March 2010, during which the cities and local authorities’ road map to Nagoya was also discussed.

The WGABS-9 meeting provided an opportunity for Ngwang Sonam Sherpa from the Nepal Indigenous Nationalities Preservation Association (NINPA) to present to the CBD Executive Secretary a traditional scarf and copper vessel for inclusion to the CBD Museum of Culture and Nature.

## Latin American and Caribbean Indigenous and Local Community Capacity-building Workshop on the CBD including issues relevant to Article 8(j), TK and ABS: Mesoamerican Region - Guatemala City, Guatemala

The meeting was the fourth workshop of a series to be held in the LAC region, held Guatemala City, Guatemala on 4-6 March 2010. A number of 35 representatives of indigenous and local communities (27 women and 8 men) of the countries of the Mesoamerican region (México, Guatemala, El Salvador, Honduras, Nicaragua, Costa Rica and Panamá) participated in the workshop. As a result, the workshop provided an opportunity to strengthen capacities of participants in understanding the processes of the Convention, preparing documents for proposals, and suggestions to improve future workshops. It also allowed the exchange of relevant national and regional experiences within the Mesoamerican subregion countries. At the end of the workshop, participants expressed that they felt better prepared to work with other members of their respective indigenous and local communities on these topics and more knowledgeable about the processes of the Convention and how to participate effectively to influence the results., and have acquired a better understanding of the agenda and the issues currently being addressed in the processes towards COP 10.

On 23 March, the Secretariat gave a presentation at Mount Pleasant Elementary school in Hudson, Quebec. The Secretariat was invited by parent volunteers to talk about biodiversity and *The Green Wave* to a group 20 grade 4 to 6 students who are part of the school's Green Team. The Secretariat took part in the Experts meeting on the relationship between the World Heritage Convention, conservation and sustainable development, which took place 29 - 31 March

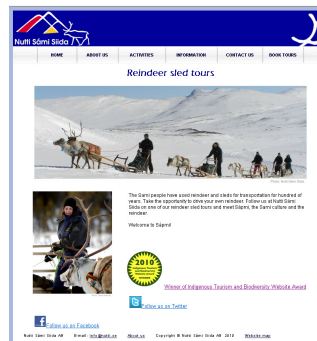

The Secretariat was invited to join the panel on the "link between heritage and development in current policies and practices: approaches, challenges and lessons learnt" and to provide input to the Expert Meeting's recommendations to the WH Committee's meeting in New York. Participants called for increased cooperation between the Biodiversity Liaison Group conventions in regard to using biodiversity (as an outstanding universal value) as a key asset for sustainable development. Invitees included representatives of UNESCO, UN-MDG Secretariat, The World Bank, UNPD, and representatives of relevant MEAs such as CITES, Man and Biospheres programme, Convention on Migratory Species (CMS) and Ramsar, amongst others.

## 2010 Indigenous Tourism and Biodiversity Website Award



The Secretariat of the Convention on Biological Diversity in collaboration with the leading sustainable travel web portal Planeta.com, and with the generous support of the Heidehof Foundation announced the winners of the second Indigenous Tourism and Biodiversity Website (ITBW) Award. Applications were received from 10 countries (Australia, Bolivia, Canada, Kyrgyzstan, Laos, Mexico, Micronesia, New Zealand, Pakistan and Sweden). Over 400 people cast their vote, examining the 14 websites that fit the ambitious criteria. Additionally, a jury composed of six internationally recognized experts in indigenous and sustainable tourism voted using the same criteria. The winner of the judged 2010 ITBW Award is Nutti Sami Siida ([www.nutti.se](http://www.nutti.se)) and the winner of the popular count 2010 ITBW Award is TIME Unlimited Tours ([www.newzealandtours.travel](http://www.newzealandtours.travel)).
