#### ANNOTATIONS TO THE PROVISIONAL AGENDA

#### INTRODUCTION

- 1. The Group of the Friends of the Co-Chairs on Liability and Redress in the Context of the Cartagena Protocol on Biosafety (hereinafter "Group of the Friends of the Co-Chairs", or "the Group") was established by the fourth meeting of the Conference of the Parties serving as the meeting of the Parties to the Cartagena Protocol on Biosafety to further negotiate international rules and procedures in the field of liability and redress for damage resulting from transboundary movements of living modified organisms. The Group has held three meetings to date. It negotiated the draft text of rules and procedures on liability and redress, mainly in the form of a supplementary protocol to the Biosafety Protocol. It provisionally adopted all but two provisions of such draft supplementary protocol.
- 2. At the conclusion of its third meeting held from 15 to 19 June 2010, in Kula Lumpur, the Group agreed to meet one more time just prior to the fourth meeting of Conference of the Parties serving as the meeting of the Parties to the Protocol in Nagoya, Japan, to further negotiate and finalize the rules and procedures on liability and redress on the basis of the text contained in the appendices to the report of its last meeting. The Group further agreed to have such meeting for a period of three days, from 6 to 8 October 2010.

These appendices will be put together and made available to the Group for its use as the working document under this agenda item (UNEP/CBD/BS/GF-L&R/4/2).

8. Under this item, the meeting may wish to consider any other matters of relevance raised by participants in the Group.

#### ITEM 5. ADOPTION OF THE REPORT

9. The Group will be invited to consider and adopt its report on the basis of a draft report prepared by the Co-Chairs. The report is expected to be submitted to the fifth meeting of the Conference of the Parties serving as the meeting of the Parties to the Protocol for its consideration in accordance with paragraph 1(h) of decision BS-IV/12.

10. The fourth meeting of the Group of the Friends of the Co-Chairs is expected to be closed by 6 p.m. on Friday, 8 October 2010.
