

#### 5. General information on access to Nadi, Fiji

Nadi is serviced by the Nadi International Airport in Nadi, Fiji (about 8 km from Nadi Town). It is located on the West of Viti Levu and the capital Suva is located to the East. Participants will be staying at the Novotel Hotel which is located close to the airport and the hotel provides a free shuttle service to and from Nadi International Airport.

## 6. Visa information



Participants from countries listed below do not require an entry visa for Fiji all others are strongly advised to contact the nearest Fijian diplomatic or consular mission **as soon as possible** in order to secure the required entry visa in a timely manner, prior to departure.

Citizens of the following countries **do not** require a visa for Fiji for a stay of up to 90 days:

Antigua and Barbuda, Argentina, Australia, Austria, Bahamas, Bangladesh, Barbados, Belgium, Belize, Bermuda, Bosnia and Herzegovina, Botswana, Brazil, Brunei Darussalam, Bulgaria, Canada, Chile, China, Colombia, Cyprus, Czech Republic, Denmark, Dominica, Estonia, Finland, France, Gambia, Germany, Ghana, Greece, Grenada, Guyana, Holy See, Hungary, Iceland, India, Indonesia, Israel, Italy, Jamaica, Japan, Kenya, Kiribati, Latvia, Liechtenstein, Lesotho, Luxembourg, Malawi, Malaysia, Maldives, Malta, Marshall Islands, Mauritius, Mexico, Micronesia (Federated States of), Moldova, Monaco, Netherlands, New Zealand, Nigeria, Norway, Palau, Papua New Guinea, Paraguay, Peru, Philippines, Poland, Portugal, Republic of Korea, Romania, Russian Federation, Saint Kitts and Nevis, Saint Lucia, Saint Vincent and the Grenadines, Samoa, Serbia, Sierra Leone, Singapore, Slovak Republic, Solomon Islands, South Africa, Spain, Swaziland, Sweden, Switzerland, Tanzania (United Republic of), Thailand, Tonga, Trinidad and Tobago, Tunisia, Turkey, Tuvalu, Uganda, Ukraine, United Arab Emirates, United Kingdom Great Britain and Northern Ireland, United States of America, Uruguay, Vanuatu, Venezuela, Zambia, Zimbabwe.

To facilitate the issuance of visas, the Secretariat will issue upon request invitation letters to be attached to the visa applications.

## 7. Health Requirements

A yellow fever vaccination certificate is required from travellers entering Fiji within 10 days of having stayed overnight or longer in countries with risk of yellow fever transmission.

#### 8. Hotel information

A block booking has been made for all delegates (sponsored and non-sponsored) at the Novotel Nadi Hotel. The room rates are FJD \$145 for a single room, FJD \$175 for a superior room and FJD \$195 for a deluxe room. ## 9. Payment of the Daily Subsistence Allowances (DSA)

The official language in Fiji is English, however, Bau Fijian, and Hindustani are also spoken.

The currency in Fiji is the Fijian Dollar (FJD \$). The current exchange rate as at 14 June 2010 is US \$1.00 = FJD \$2.02 and = \$1.00 = FJD \$2.44.
