Such accreditation is strictly reserved for representatives of bona fide media organizations who fully meet <u>UN media accreditation requirements</u>.<sup>1</sup>

### Accreditation procedure

Along with this form applicants should send by fax a copy of the following:

- A letter of assignment on official letterhead of their media organization signed by an authorized person (Editor, Bureau Chief or Publisher). It should specify the name and functional title of the journalist.
- Photocopy of a valid press card.

Participants are encouraged to submit their accreditation request form **no later than 20 May 2005**. It should be noted that double accreditation (e.g. as press and delegate or NGO) is not allowed.

### Registration

Upon arrival in Montreal, participants will be required to present their original press card and two forms of photo ID (passport, driver's license or work ID) at the registration desk located at the lower atrium of the ICAO building. Registration will commence on Friday, 27 May 2005 and will continue on Sunday, 29 May from 3 to 6 p.m. and on Monday, 30 May 2005 from 8 a.m. Accredited journalists will be issued with press identification badges in order for them to gain access to the conference venue and the public sessions.
