#### Comments on roadmap

While this roadmap is feasible, we can expect some challenges still related to human resources with the EPA. Note that the role of 'content manager' still will remain as one of many other tasks that an officer is responsible for. However, a deliberate effort will be made to incorporate CHM website maintenance on the monthly workplan.

Also, this will be a similar challenge with 'nominated' liaisons within our various stakeholders. Moreover, we do not control their efforts in ensuring it is place on their work programme. However, from the EPA will make best efforts to keep in close contact with these individuals via emails or if feasible, through the establishment of a blog (a present success story in the case of Trinidad and Tobago.

#### Cooperation opportunities / Type of support needed

The interaction from the CHM workshop held in St. Lucia is a testament to how we can learn from both the challenges and successes from other countries in our region as the work toward establishment and maintenance of a National Clearing House Mechanism.

The opportunity allows for the continuous communication of participants from the workshop as they proceed with their National CHMs. Participants should make an effort to remain in contact with countries that are at the same stage of CHM development and also any particular country that can provide support to them. (This is case, Jamaica and Trinidad & Tobago have been flagged as good examples for Guyana to learn from in moving forward with our National CHM.
