Badges

Health Requirements

9. There are no vaccination requirements for any international traveler.

Hotel Information

10. Participants are responsible for making their own hotel bookings. The month of July being a peak tourist season, and it is recommended that participants arrange their hotel accommodation as early as possible. For hotel room rates and coordinates, please refer to Annex B of the information note for participants of SBSTTA-12 and WGRI-2. Credit cards or cash deposits are required for hotel reservations.

Arrival/Departure at/from Paris Airports

11. Paris is serviced by two international airports namely Charles de Gaulle and Orly. These two airports are serviced by public transport (RER and Bus), by taxis and limousines as well as trains. Miscellaneous Information on France

- 12. The official language in France is French. However, English is also spoken and understood in hotels and restaurants.
- 13. In July, typical daytime temperatures in Paris range between 20° C and 30° C. The standard time zone is GMT + 1 hour.
- 14. Electricity is available at 220 volts and a frequency of 50 Hertz.
- 15. The currency used in France is the Euro. The current exchange rate is approximately US \$1 = EUR \$0.78. Facilities in currency exchange are readily available in banks and hotels.
