Registration

- 6. Registration will commence on **Friday 16 May**, and will continue on **Saturday 17** and **Sunday 18 May 2008**. The registration counter will be located outside the Maritim Hotel Bonn and will be open from 9 a.m. to 6 p.m.
- 7. Based on the notifications received by the Secretariat, name badges with photographs and barcodes will be issued at the registration counter upon presentation of a valid passport or an identification card with a photograph.
- 8. For security reasons, and to gain access to both meeting venue and meeting room, the display of name badges is mandatory at all times. Any loss of a name badge should be reported in a timely manner to the registration counter.
