PERIODICITY OF MEETINGS AND ORGANIZATION OF WORK OF THE CONFERENCE OF THE PARTIES

Note by the Executive Secretary

- 1. In paragraph 1 of its decision IX/29, the Conference of the Parties welcomed as a useful input into the further consideration of the periodicity of its meetings and its subsidiary bodies the report by the Executive Secretary (UNEP/CBD/COP/9/22/Add.1) on options for the meeting schedule and organization of work of the Conference of the Parties after 2010. In paragraph 2 of the same decision, it requested the report to be updated by the Executive Secretary as needed and made available for the consideration of the Working Group on the Review of Implementation at its third meeting and forwarded to the Conference of the Parties at its tenth meeting, taking into consideration the relationship between the periodicity of the meetings of the Conference of the Parties and its subsidiary bodies and the revision and updating of the Strategic Plan as well as a multi-year programme of work for the period 2011-2022.
- 2. The very large number of variables made the presentation of all possible options unworkable. Therefore, a list of 14 options has been compiled, analysed and reflected by the Secretariat in table 1 attached to this note. An indicative 12-year calendar for each of these options is presented in table 2.
- 3. The options are clustered first as those where the periodicity of meetings of the Conference of the Parties could be annual, biennial or triennial. These could be of one or two-week duration.
- 4. Within these clusters, options for the periodicity of meetings of the Subsidiary Body on Scientific, Technical and Technological Advice (SBSTTA) are presented. Depending on the length of the meeting option of the Conference of the Parties, SBSTTA meetings could be intersessional and either "back-to-back to" or "concurrent with" the Conference of the Parties.
- 5. Finally, because of the longer period between meetings of the Conference of the Parties in the triennial cluster of options for the Conference of the Parties, proposals have been included for an

enhanced intersessional body such as a standing committee, joint meetings of the Bureaux of the Conference of the Parties and the Subsidiary Body on Scientific, Technical and Technological Advice (SBSTTA), or an enlarged Bureau of the Conference of the Parties.

- 6. The financial implications of each option presented in table 1 and in tables 3-A (Consolidated financial implications over twelve years) and 3-B (Consolidated financial implications over 12 years sorted by total savings) have been updated but they are estimates only. They are based on both the number of meetings of the Convention's primary bodies presented in a particular option, and on how these meetings would organize their work. Furthermore, they are presented over the course of twelve years, with an estimate of inflation added, because in this way the significance of the financial implications over a period of time can more easily be demonstrated.
- 7. The nominal cost of each meeting has been estimated by the Secretariat drawing from past experience. It also reflects the Secretariat's proposals drawn from a comparative analysis with governing bodies of multilateral environmental agreements and other intergovernmental processes of relevance to the Convention on Biological Diversity presented at the second meeting of the Working Group on Review of Implementation (UNEP/CBD/WGRI/2/INF/12) to organize COP and SBSTTA meetings respectively around a plenary and committee of the whole (COW). A committee of the whole would be in lieu of two working groups. Such an arrangement is foreseen to result in significant in-session savings, related primarily to lower interpretation costs.
- 8. The estimated costs of each option have then been compared to the Convention's "business-as-usual" *modus operandi*: a biennial meeting of the Conference of the Parties of two-week duration and two inter-sessional SBSTTA meetings each of one-week duration. In the business-as-usual scenario, COP and SBSTTA operate with two working groups.
- 9. It is important to note that the decision of the Conference of the Parties on a post-2010 option for the meeting schedule is dependent in part on the finalization of the Convention's revised Strategic Plan and the accompanying revised multi-year programme of work (MYPOW).
- 10. Finally, for reasons similar to those described in the preceding paragraph, open-ended intersessional meetings for the post-2010 period have not been suggested in the table. This is because their need primarily depends on the revised Strategic Plan and the revised MYPOW. However, for discussion purposes the Secretariat estimates the nominal cost of one, one-week meeting at US\$ 350,000.
