## CBD-UNESCO CONSULTATIVE WORKING GROUP OF EXPERTS ON BIOLOGICAL DIVERSITY EDUCATION AND PUBLIC AWARENESS

(Third Meeting, Bilbao, Spain, 13-15 September 2001)

We are pleased to announce that the CBD-UNESCO Consultative working group of experts, charged with developing and testing a global initiative on biological diversity education and public awareness, based on implementation of Article 13 and as a follow-up of decision V/17 adopted at the Fifth Conference of the Parties of the Convention on Biological Diversity, will hold its third meeting from 13 to 15 September 2001 in Bilbao, Spain.

The Global Initiative aims to create dynamics or awareness leading to participation and action in the conservation, sustainable use and equitable sharing of benefits of biological diversity; and to provide an overall strategy for the implementation of national and international solutions to specific issues in the area of biodiversity education and public awareness.

The main objectives of the three-day meeting include the further design and implementation of the strategy, the finalization of operational elements and suggested action, including in the form of demonstration projects and best practices. A feasible timetable of targets will complete the strategic focus of the meeting.

You are cordially invited to attend the meeting as your participation and your valuable expertise in the field of biological diversity education and public awareness is important to the success of the meeting.
