ORGANIZATION OF WORK: ADOPTION OF THE AGENDA*Annotations to the provisional agenda***INTRODUCTION**

1. In its decision VII/12, the Conference of the Parties to the Convention on Biological Diversity invited Parties, Governments, and relevant organizations to initiate a process for the implementation of the Addis Ababa Principles and Guidelines for the Sustainable Use of Biodiversity, and requested the Executive Secretary, *inter alia*, "to convene a series of technical experts workshops on ecosystem services assessment, financial costs and benefits associated with conservation of biodiversity, and sustainable use of biological resources".
2. In response to this request, the Executive Secretary is organizing a series of technical expert regional workshops with financial assistance from the Government of the Netherlands. The Central and Eastern European Regional Expert Workshop on the Sustainable Use of Biological Diversity is the first regional workshop being organized. It will take place in Moscow, at the kind invitation of the Government of Russia, from 30 May to 2 June 2005.
3. In accordance with the request in decision VII/12, the Workshop will focus on ecosystem services assessment, financial costs and benefits associated with conservation of biodiversity, and sustainable use of biological resources. Moreover, it will provide a forum for government officials and practitioners to enhance their awareness and understanding of the Addis Ababa Principles and Guidelines for the Sustainable Use of Biodiversity and promote the use of these guidelines in an integrated manner, as a contribution to facilitating the achievement of the 2010 target, sustainable development and poverty alleviation.
4. Participants in the Workshop have been invited to present case-studies on the sustainable use of biological resources in their home countries. Guidelines for the preparation of case-studies were provided to participants in advance of the Workshop. The case-studies will be selected to cover a broad spectrum of resource uses and regional or local conditions. The review of case-studies will focus on, as appropriate: (i) best practices and lessons learned from the use of biological diversity; (ii) implementation of the Addis Ababa Principles and Guidelines for the Sustainable Use of Biodiversity; (iii) lessons learned

as regards to ecosystem services assessment; and (iv) lessons learned as regards to financial costs and benefits associated with the conservation and sustainable use of biological diversity.

5. Participants in the Workshop were selected from among government-designated experts based on expertise, taking into account gender balance and geographical distribution.

6. In order to prepare adequately for the regional workshop, a training manual on the *Sustaining Uses of Biological Diversity* has been prepared by IUCN in coordination with the Secretariat. The manual will be distributed to all participants at the venue of the workshop. In addition, a provisional list of the documents for the Workshop is also provided in annex I below.

7. The Secretariat has circulated an information note for participants containing details on logistical arrangements for the meeting, including information on travel, visa requirements, accommodation and other matters.

ITEM 1. OPENING OF THE MEETING

8. The representative of the Secretariat of the Convention on Biological Diversity will open the Workshop at 9 a.m. on Monday, 30 May 2005. Representatives from the host country and WWF Russia, as the designated local organizer, will make introductory remarks. Introductory remarks will also be given by representatives from IUCN, who will act as facilitators to the meeting.

ITEM 2. ORGANIZATIONAL MATTERS

2.1. Adoption of the agenda

9. The Workshop will be invited to adopt its agenda on the basis of the provisional agenda (UNEP/CBD/RW-SU-CEE/1), which has been prepared by the Executive Secretary in line with paragraph 5 of decision VII/12 of the Conference of the Parties.

2.2. Organization of work

10. The languages of the meeting will be English and Russian. Simultaneous interpretation will be provided.

11. A suggested timetable for the workshop, indicating the allocation of time for each agenda item, is provided in annex II below.

ITEM 3. REVIEW OF KEY TERMS AND CONCEPTS USED IN THE ADDIS ABABA PRINCIPLES AND GUIDELINES FOR THE SUSTAINABLE USE OF BIODIVERSITY AND OTHER CBD RELEVANT TOOLS AND INSTRUMENTS

12. In order to facilitate the implementation of the principles and guidelines for sustainable use of biodiversity, the clear understanding of terms and concepts used is essential.

13. In light of this, participants will be invited to review a number of terms and concepts to ensure that they are communicating effectively. They will also be invited to review a number of other relevant tools and instruments that were developed under the Convention and may provide further guidance in the implementation of the Addis Ababa Principles and Guidelines.

ITEM 4. REVIEW OF THE ADDIS ABABA PRINCIPLES AND GUIDELINES FOR THE SUSTAINABLE USE OF BIODIVERSITY

14. The fourteen Addis Ababa Principles for the Sustainable Use of Biodiversity will be briefly introduced and reviewed by facilitators. The rationale of each principle along with the operational guidance provided in the decision of the Conference of the Parties to the Convention on Biological Diversity will be explained, and where possible, case-study examples will be presented to illustrate the relevance of the principle using “real-life” situations.

15. Under this agenda item, participants are invited to review the Addis Ababa Guidelines by presenting and considering case-study information provided by participants prior to the course.

ITEM 5. APPLICATION OF THE ADDIS ABABA PRINCIPLES AND GUIDELINES FOR THE SUSTAINABLE USE OF BIODIVERSITY

16. As explained in the annotation to item 4 above, the Addis Ababa Principles are intended to be of general relevance, although not all principles will apply equally to all situations, nor will they apply with equal rigour. Application of the Principles will vary according to the biodiversity being used, the conditions under which they are being used, and the institutional and cultural context in which the use is taking place. The application of these Principles should be in the context of the ecosystem approach, as endorsed at the Conference of the Parties to the Convention on Biological Diversity held in Kuala Lumpur, in February 2004.

17. Under this agenda item, participating experts will be invited to explore the applicability of the Addis Ababa Guidelines in concrete biodiversity management problems by elaborating management plans using case-study information provided by participants prior to the Workshop.

ITEM 6. ECOSYSTEM SERVICES ASSESSMENT

18. Conservation of biodiversity is essential as a source of particular biological resources, to maintain different ecosystem services, to maintain the resilience of ecosystems, and to provide options for the future. The benefits that biodiversity provides to people have not been well reflected in decision-making and resource management and, thus, the current rate of loss of biodiversity is higher than what it would be, had these benefits been taken into account. ^{1/}

19. Tools now exist for a far more complete assessment of the consequences of biodiversity loss for human well-being, but most decisions continue to be made in the absence of a detailed analysis of the full costs, risks and benefits. Various valuation methods are available to estimate the different biodiversity values and their changes under different policy or management alternatives. Despite the existence of these tools, only provisioning ecosystem services are routinely valued.

20. After a brief introduction by the facilitators, under this item, experts will be invited to consider the issues of: (i) the impacts of sustainable use and non-sustainable use on livelihoods, and ecosystems good and services; (ii) socio-economic factors that influence pattern and intensity of use of biological resources; and (iii) economic and social values of goods and services provided by ecosystems.

21. Participants will also be invited to consider a note by the Executive Secretary on the Millennium Ecosystem Assessment: review of the draft reports, in particular the draft synthesis report prepared for the Convention on Biological Diversity (UNEP/CBD/SBSTTA/10/6).

**ITEM 7. FINANCIAL COSTS AND BENEFITS ASSOCIATED WITH THE
CONSERVATION AND SUSTAINABLE USE OF BIOLOGICAL
DIVERSITY**

22. Biodiversity policies and the management of biodiversity resources have different types of costs and benefits, including financial costs and benefits that need to be adequately taken into account for effective policy planning and decision-making. Moreover, these costs and benefits are changing the distributional patterns that existed before the introduction of the policy. They are distributed between different groups, on a different geographical scale and across different time horizons.

23. After a brief introduction by facilitators, participants may wish to review the different types of costs and benefits associated with conservation and sustainable use of biodiversity, address the role of financial costs and benefits, and discuss possible distributional effects and their implications for the successful implementation of biodiversity policies and programmes. As appropriate, the discussion will be based on selected regional case-studies to be presented by participants.

24. Participants will also be invited to consider the above-mentioned note by the Executive Secretary on the Millennium Ecosystem Assessment: Review of the draft reports, in particular the draft synthesis report prepared for the Convention on Biological Diversity (UNEP/CBD/SBSTTA/10/6).

ITEM 8. ASSESSMENT OF THE WORKSHOP

25. A brief assessment of the workshop will give participants the opportunity to evaluate to what extent the Workshop has met their expectations and its objectives. Feedback will help update/revise the workshop to better serve future participants.

ITEM 9. OTHER MATTERS

26. Under this item, participants may wish to raise for discussion other issues related to the subject matter of the Workshop, including suggestions for further activities on sustainable use under the Convention.

ITEM 10. ADOPTION OF THE REPORT

27. Participants in the Workshop will consider and adopt its report on the basis of the draft report of the meeting to be prepared and presented by the representative of the Secretariat. The final report of the Workshop will be submitted to SBSTTA at its eleventh meeting for its consideration prior to the eight meeting of the Conference of the Parties.

ITEM 11. CLOSURE OF THE MEETING

28. The meeting will be closed at 5 p.m. on Thursday, 2 June 2005.
