

5. General information on access to Buenos Aires, Argentina



Buenos Aires is serviced by the Ministro Pistarini International Airport (Ezeiza). The airport is situated in Ezeiza, about 37 km southwest of the city centre.

Taxis are available for travel to the city of Buenos Aires by identified taxis and private cars called "remises" or by private buses located outside terminals A and B, the cost of travel to the city centre is approximately US \$30 - US \$35 and should take approximately 30-40 minutes. For this workshop, citizens of the following countries and territories <u>do not</u> require a visa to **visit** or **transit** Argentina: Chile, Panama, Paraguay and Uruguay.

The official language in Argentina is Spanish.

10. Weather and time zone information



In February, temperatures in Buenos Aires usually range between a maximum of $+30^{\circ}$ C in the daytime and a minimum of $+25^{\circ}$ C at night. The climate is rainy at this time of the year. Current weather conditions can be found at: http://www.worldweather.org/050/c00294.htm.

11. Electricity

The electrical currents are 220 volts, 50 Hertz. There are two type of plugs used in Argentina depending on the area and type of building. The first plug has a grounding pin and two flat prongs forming a V-shape and the type of socket used is illustrated below.



The second type is found in older buildings is two round pins and the type of socket is illustrated below.



12. Currency



The currency in Argentina is the Pesos (ARS). The current exchange rate as at 26 January 2010 is US \$1 = ARS \$3.80, €1 = ARS \$5.36.
