#### **NOTIFICATION**

Subject: The meeting of the *Ad hoc* technical expert group on mariculture, Rome, Italy, 1-5 July 2002

Pursuant to decision IV/5 on the conservation and sustainable use of marine and coastal biological diversity, the Conference of the Parties decided to establish an *Ad hoc* technical expert group on mariculture. The expert group was established under programme element 4 (mariculture) of the programme of work on marine and coastal biological diversity. The function of the expert group is to assist the Subsidiary Body on Scientific, Technical and Technological Advice (SBSTTA) in its work on this topic. The meeting of the expert group will be held in collaboration with the Food and Agriculture Organization of the United Nations (FAO).

I am pleased to convey herewith the composition of the *Ad hoc* technical expert group on mariculture. The composition of the expert group was determined by the Executive Secretary in consultation with the SBSTTA Bureau, and based on nominations from Parties. The selection process took into account the participants' demonstrated expertise and experience (in the field of mariculture); and a balanced geographical distribution within and between regions.
