

### **NOTIFICATION**

Subject: Expert Meeting on the Global Strategy for Plant Conservation County Kerry, Republic of Ireland 5 to 7 October 2003


Madam/Sir,

At its sixth meeting, the Conference of the Parties (COP) to the Convention on Biological Diversity endorsed the Global Strategy for Plant Conservation (GSPC). In section E of the annex to decision VI/9 in which the further work required to develop and implement the Global Strategy is described and in paragraph 19 of the annex, the COP specified that the design, development and implementation of the strategy should involve, in addition to the Parties to the Convention, a range of other actors, including international initiatives, conservation and research organizations, communities and major groups and the private sector. In paragraph 10(b) of the same decision, the COP requested the Subsidiary Body on Scientific, Technical and Technological Advice (SBSTTA) to develop ways and means, within the Convention's thematic and cross-cutting programmes of work, for promoting implementation of the Global Strategy, and for monitoring and assessing progress; and to report to the Conference of the Parties at its seventh meeting.

To facilitate the further implementation of the Global Strategy for Plant Conservation, the Secretariat of the Convention on Biological Diversity is organizing, in collaboration with the Botanic Gardens Conservation International and its five-year partnership funded by HSBC plc "Investing in Nature" (other partners include also Earthwatch and WWF), a meeting of experts in County Kerry, Republic of Ireland, from 5 to 7 October 2003, (at the Dingle Skellig Hotel, Dingle, Co. Kerry), to prepare advice, pursuant to the requests in decision VI/9.

Further to the notification dated 11 August 2003 inviting Parties to the Convention to nominate experts in the fields of plant conservation, monitoring and assessment, I am pleased to convey herewith the composition of the group of selected
