**Subject: International Workshop on Protected Forest Areas
6 to 8 November 2003
Montreal, Canada**

Dear Madam/Sir,

In paragraph 19 (d) of decision VI/22 on Forest Biological Diversity, the Conference of the Parties requested the Executive Secretary to prepare and hold an international workshop on protected areas as a measure to conserve and sustainably use forest biological diversity. The purpose of the workshop is to exchange current knowledge and experience on opportunities and challenges to establishing and ensuring long-term sustainability of protected forest areas. This workshop should provide recommendations for the further implementation of activities relevant to protected forest areas in the work programme (element 1, goal 3, objective 3), and will report to the Subsidiary Body on Scientific, Technical and Technological Advice at its ninth meeting (SBSTTA-9) under the agenda item on protected areas.

In response to this decision, I am pleased to inform you that, with the financial support of the Government of the Netherlands, I am convening an International workshop which will take place in Montreal, Canada from 6 to 8 November 2003, prior to the ninth meeting of the Subsidiary Body on Scientific, Technical and Technological Advice (SBSTTA-9).

Further to notifications 2003-082 of 14 August 2003 and 2003-084 of 18 August 2003, Parties to the Convention, other Governments, UN Organizations and Specialized Agencies, Inter-governmental Organizations, Non-governmental Organizations and Indigenous and Local Communities Organizations have nominated experts for participation in this International workshop. A list of these nominations is contained in annex 1 to the current notification and letters of invitation are being prepared accordingly.

Funding for the participation, enabled through the financial support from the Netherlands, will be limited to the experts listed in annex 2. However, those nominated experts not listed in annex 2 are welcome to attend if they can obtain their own sources of funding.
