# **NOTIFICATION**

## Questionnaire to facilitate the submission of information on the progress in, and effectiveness of, the implementation of the Action Plan for Building Capacities for the Effective Implementation of the Cartagena Protocol on Biosafety

Madam/Sir,

The Conference of the Parties to the Convention serving as the meeting of the Parties to the Cartagena Protocol on Biosafety (COP-MOP) in its decision BS-I/5 adopted an Action Plan for Building Capacities for the Effective Implementation of the Protocol and a Coordination Mechanism for its implementation. In paragraph 5 of that decision, COP-MOP agreed to undertake a comprehensive review and possible revision of the Action Plan at its third meeting, which is scheduled to take place from 13 to 17 March 2006 in Curitiba, Brazil.

At its second meeting, COP-MOP in decision BS-II/3 adopted terms of reference for the comprehensive review of the Action Plan and outlined a process to facilitate the review and possible revision of the Action Plan at the third meeting. It invited Parties, other Governments and relevant organizations to submit to the Secretariat, no later than three months prior to its third meeting, information on progress made in, and effectiveness of, the implementation of the Action Plan as well as views and suggestions on desired revisions to the Action Plan, taking into account the terms of reference for the review. COP-MOP also requested the Executive Secretary to prepare a questionnaire to assist Parties, other Governments and relevant organizations in submitting the above-mentioned information. The Executive Secretary was requested to also include in the questionnaire elements to assess the constraints encountered with the implementation of the Coordination Mechanism and the possible reasons behind the limited use of the roster of biosafety experts.

I am pleased to forward to you the questionnaire prepared by the Secretariat pursuant to the request and guidance provided by the COP-MOP. It consists of three main parts focussed on A: the Action Plan, B: the Coordination Mechanism and C: the roster of experts, respectively. As was recommended by the COP-MOP in decision BS-II/3 (Annex, Section C), the questionnaire is easy to complete and uses simple check boxes and yes/no questions as well as a few text open-ended questions. It is also accessible through the Biosafety Clearing-House (http://bch.biodiv.org).
