Subject: Joint Article 8(j) and Clearing-House Mechanism Capacity-Building Workshop on Networking and Information Exchange (Latin America and the Caribbean Region), Quito, Ecuador, 14-16 December 2006

Dear Madam/Sir,

I am writing in connection with decision VIII/5 and VIII/11 of the Conference of the Parties, on Article 8(j) and related provisions and on Scientific and Technical Cooperation and the Clearing-House Mechanism, respectively.

In decision VIII/5D paragraph 6(a), the Conference of the Parties requested the Executive Secretary: "to convene, subject to the availability of financial resources, regional and subregional workshops on new information and web-based technologies to assist indigenous and local communities in their use and to facilitate the establishment of communication networks".

In decision VIII/11, Annex II, Activity 1.1.1. of the Strategic Plan, the Conference of the Parties requested the Executive Secretary: "to organize joint technical hands-on workshops with partners and international thematic focal points on new information and web-based technologies to assist in the implementation of the Convention, taking into account the special needs of indigenous and local communities".

In accordance with these decisions, a Joint Article 8(j) and Clearing-House Mechanism regional workshop will be convened for the Latin America and Caribbean region with the generous support of the Governments of Spain and the Netherlands. This workshop seeks to enhance the capacity of the countries in the region by sharing experiences on networking and information exchange, including new information and web-based technologies, with a focus on the special needs of indigenous and local communities.
