NOTIFICATION

Submission of First Regular National Reports

Madam/Sir,

Reference is made to decision BS-III/14, paragraph 3, of the Conference of the Parties to the Convention serving as the meeting of the Parties to the Protocol (COP-MOP), which requests Parties to submit their first regular national reports on the implementation of the Cartagena Protocol on Biosafety, as called for under Article 33 (Monitoring and Reporting) of the Protocol. Further reference is made to paragraph 28 of the report of the third meeting of the Compliance Committee (UNEP/CBD/BS/CC/3/3) in which the Committee requested the Secretariat to urge Parties to submit their national reports not only as an important input for planning future work by the COP-MOP, but also as an essential compliance issue in itself.

Accordingly, Parties are reminded that first regular national reports are to be submitted to the Secretariat no later than **11 September 2007**, in an official language of the United Nations, in both hard copy and electronic Word format, and using the reporting format annexed to decision BS-III/14. The reporting format is available on the Secretariat's website at: http://www.biodiv.org/biosafety/issues/monitoring.shtml.

In addition, Parties, other Governments, relevant intergovernmental and non-governmental organizations and other stakeholders have been invited by COP-MOP to evaluate the effectiveness of the Protocol in accordance with Article 35 on assessment and review, and to provide their views as specified in decision BS-III/15 and decision BS-III/1. In that regard, additional questionnaire containing those questions specified in the relevant decisions of COP-MOP in the context of **assessment and review**, is attached herewith. The Secretariat kindly asks each Party to complete the questionnaire and forward its submission, preferably, as part of or as an addendum to the first regular national report.

Thank you for your continued cooperation and support towards the work of the Cartagena Protocol on Biosafety.
