I have the pleasure to inform you that, with the generous financial support of the Government of Ecuador and the European Union, the Secretariat of the Convention on Biological Diversity (CBD) is organizing from 23 to 25 September 2008 in the City of Salinas, Province of Santa Elena, Ecuador, a sub-regional workshop on capacity building for the implementation of the CBD programme of work on protected areas.

The offer from the Government of Ecuador to host this workshop was welcomed by the Conference of the Parties in paragraph B 11 of decision IX/18. The provisional agenda for the workshop is annexed to this notification. Other meeting documents will be posted on the CBD website in due course. The workshop will be conducted in Spanish.

I invite you to nominate one representative, at your earliest convenience but not later than **15 August 2008,** to participate in the workshop. - The representative should be involved in the implementation of the programme of work on protected areas;
- After the workshop, the country representative should be in a position to translate the capacity gained into concrete actions; and
- The representative should be in a position to participate in the exchange of information on the status of implementation of the programme of work on protected areas and on ways and means to implement decision IX/18.

The nominations should be accompanied by curriculum vitae that clearly indicate the areas of expertise of the nominee.

I would like to thank you in advance for your cooperation in this matter, and your continued support for the work of the Convention.
