Submission of guiding questions in preparation for the online conference on the need and modalities for developing standards on identification, handling, packaging and transport of living modified organisms (paragraph 3 of Article 18 of the Cartagena Protocol on Biosafety)

Madam/Sir,

I would like to draw your attention to decision BS-IV/10 of the fourth meeting of the Conference of the Parties serving as the Meeting of the Parties to the Biosafety Protocol where Parties, other Governments and relevant international organizations were invited to provide the CBD Executive Secretary with guiding questions for an online conference on paragraph 3 of Article 18.

The online conference is intended to: (i) identify the relevant standards with regard to handling, transport, packaging and identification of living modified organisms; (ii) identify where gaps exist; and (iii) suggest possible modalities to fill the gaps.

I would greatly appreciate it if the guiding questions reach the Secretariat as soon as possible, but **no later than 31 October 2008**. The attached information note is intended to provide background information on paragraph 3 of Article 18 and the online conference.

Background note for the online conference on paragraph 3 of Article 18 of the Cartagena Protocol on Biosafety

Paragraph 3 of Article 18 provides that the Conference of the Parties serving as the meeting of the Parties (COP-MOP) to the Protocol "shall consider the need for and modalities of developing standards with regard to identification, handling, packaging and transport practices, in consultation with other relevant international bodies."

In decision BS-IV/10 adopted at the fourth meeting of COP-MOP, held in Bonn, Germany in May 2008, the Parties requested the Executive Secretary to organize an online conference on paragraph 3 of Article 18 and to prepare a summary of the outcome of the conference, reflecting the full range of views expressed, for the consideration of COP-MOP-5. Parties, other Governments and relevant international organizations are invited to provide guiding questions for the online conference and the Executive Secretary is requested to finalize the list of questions in consultation with the COP-MOP Bureau.

In the past, the Executive Secretary has prepared a number of documents on paragraph 3 of Article 18 as part of the processes of the Intergovernmental Committee for the Cartagena Protocol on Biosafety (ICCP) and for COP-MOP-1, COP-MOP-3 and COP-MOP-4. The table below provides a summary of these documents and their Article 18.3-related content. These documents contain information on existing standards relating to the handling, transport, packaging and identification of living modified organisms and are available through the Secretariat's website (www.cbd.int). The Parties, other Governments and relevant international organizations are encouraged to draw upon this work in formulating their questions for submission to the Executive Secretary.

Once the guiding questions have been received by the Executive Secretary, a compilation of the questions will be made for the consideration of the COP-MOP Bureau. The questions approved by the COP-MOP Bureau will be used to guide the design of the online conference and the modalities for its conduct. Further information on the conference, including the dates when it will take place and means of participation, will be made available in due course.
