Seventh meeting of the *Ad Hoc* Open-ended Working Group on Access and Benefit-sharing: Informal consultations with the Co-chairs and regional consultations 31 March - 1 April 2009, UNESCO, Paris, France

I am pleased to inform you that the Co-chairs of the *Ad Hoc* Open-ended Working Group on Access and Benefit-sharing (ABSWG), Mr. Fernando Casas of Colombia and Mr. Timothy Hodges of Canada, will be holding informal consultations in Paris, France, on 31 March and 1 April 2009 prior to the seventh meeting of ABSWG, which will also be held in Paris on 2-8 April 2009 at the Headquarters of the United Nations Educational, Scientific and Cultural Organization (UNESCO). In order to gain access to the UNESCO Annex, delegates are kindly requested to first obtain their meeting badges at the entrance to UNESCO Headquarters located at 125, avenue Suffren, 75015 Paris, which will be valid for the duration of ABSWG-7.
