I am pleased to confirm that the eighth meeting of the Ad Hoc Open-ended Working Group on Access and Benefit-sharing (WG-ABS 8) will be held at the International Civil Aviation Organization (ICAO) Headquarters in Montreal, from 9-15 November 2009.
