## NOTIFICATION

## Designation of a National Focal Point for Access and Benefit-sharing (ABS NFP)

Dear Madam/Sir,

At its fifth meeting, the Conference of the Parties requested "Parties to designate a national focal point and one or more competent national authorities, as appropriate, to be responsible for access and benefit-sharing arrangements or to provide information on such arrangements within its jurisdiction" (decision V/26, paragraph 1). The Conference of the Parties also urged Parties to notify the Executive Secretary of the names and addresses of their national focal points and competent authorities (decision V/26, paragraph 2).

As a follow up to these requests by the Conference of the Parties, I wish to draw your kind attention to the fact that your Government has not yet nominated a national focal point for access and benefit-sharing. With the anticipated finalization of the International Regime on Access and Benefit-sharing, in 2010, you will no doubt agree that this measure takes on added significance.

I therefore invite your Government to submit to the Secretariat the name and contact details of your designated national focal point on access and benefit-sharing at your earliest convenience and no later than 26 February 2010.

I wish to thank you for your cooperation and for your support of the work of the Convention.
