## Joint Notification from the Secretariats of the CBD and IPCC regarding Preparations for the IPCC Fifth Assessment Report

Dear Madam/Sir,

The present notification is a follow up to notification ref.: SCBD/STTM/JW/ac/74869 (2011-026) sent on 4 February 2011.

The Intergovernmental Panel on Climate Change (IPCC) has begun preparations for its Fifth Assessment Report (AR5). This report will consist of three Working Group Reports and a Synthesis Report. The Working Group I report will be finalized in 2013; the other volumes in 2014.

A number of cross-cutting issues have been identified which will receive special attention in preparing the AR5. Cross-cutting themes with specific relevance to biodiversity include Water and the Earth system: changes, impacts and responses, Carbon Cycle, and Mitigation, Adaptation and Sustainable Development. A number of workshops have been held and are planned on crosscutting and other issues in support of the assessment process. The most recent one was dealing with ocean acidification.
