NOTIFICATION

Activities resulting from decision XI/1 of the eleventh meeting of the Conference of the Parties on the status of the Nagoya Protocol on Access to Genetic Resources and the Fair and Equitable Sharing of Benefits Arising from their Utilization and related developments

Dear Madam/Sir,

The purpose of this notification is (i) to provide information on planned activities for the biennium 2013-2014 in light of decision XI/1 of the Conference of the Parties on the status of the Nagoya Protocol on Access and Benefit-sharing and related developments (ii) to invite Parties, other Governments, relevant international organizations, indigenous and local communities and stakeholders to provide information and views to the Secretariat in preparation for the third meeting of the Intergovernmental Committee for the Nagoya Protocol, and (iii) to highlight invitations by the COP for Parties, other Governments and relevant organisations to take direct action on a number of issues.

Inter-sessional activities for the biennium 2013-2014

In decision X1/1, section A, paragraph 2, the Conference of the Parties decided "to reconvene the Intergovernmental Committee for the Nagoya Protocol for a third meeting to address outstanding issues in its work plan, in preparation for the first meeting of the Conference of the Parties serving as the meeting of the Parties to the Protocol". The Conference of the Parties also decided on the following inter-sessional activities in preparation for the third meeting of the Intergovernmental Committee:

- a) Conducting a broad consultation and convening an expert meeting on the need for and modalities of a global multilateral benefit-sharing mechanism in accordance with decision XI/1, section B (tentative date: September 2013);
- b) Convening an expert meeting on measures to assist in capacity-building and development under the Nagoya Protocol, including the development of a draft strategic framework in accordance with decision XI/1, section D, paragraph 4 (tentative date: June 2013); and
- c) The further development of the pilot phase of the ABS Clearing-House, including a meeting of the Informal Advisory Committee established for the pilot phase in accordance with decision XI/1, section C (tentative date: June 2013).

Further details on these activities will be provided in due course.

<u>Submission of information and views in preparation for the third meeting of the Intergovernmental Committee</u>

In decision XI/1, section A, paragraph 6, the COP decided that the third meeting of the Intergovernmental Committee should address the following additional issues: (a) Monitoring and reporting; (b) Exchange of views on the development, updating and use of sectoral and cross-sectoral model contractual clauses, voluntary codes of conduct, guidelines and best practices and/or standards; and (c) Exchange of views on the state of implementation of the Nagoya Protocol.

In addition, in paragraph 4 of the same decision, the COP invited Parties, other Governments, relevant international organizations, indigenous and local communities and all interested stakeholders to submit information to the Executive Secretary on model contractual clauses, voluntary codes of conduct, guidelines and best practices and/or standards.

Against this background, Parties, other Governments, international organizations, indigenous and local communities and relevant stakeholders are kindly invited to provide views and/or relevant information to the Executive Secretary on the following issues for the consideration of the Intergovernmental Committee:

- a) Monitoring and reporting (Article 29);
- b) Development, updating and use of sectoral and cross-sectoral model contractual clauses, voluntary codes of conduct, guidelines and best practices and/or standards (Article 19 and 20).

Please note that submissions should be sent **as soon as possible and no later than 1 September 2013,** under cover of an official letter addressed to the Executive Secretary by e-mail to secretariat@cbd.int. To facilitate preparatory work for the meeting, submissions should be provided in **Word format**

In addition, Parties are also invited to provide to the Executive Secretary information on national or regional developments of relevance to the ratification and implementation of the Nagoya Protocol, as it becomes available.

Invitations for direct actions by Parties, other Governments and relevant organisations

In addition to the submission of views and information, the Conference of the Parties invited Parties, other Governments and relevant organisations to take direct action on a number of issues. A number of invitations for action were also made to Parties, other Governments and relevant organisations by the second meeting of the Intergovernmental Committee. Please find attached herewith a list of these invitations for your consideration.
