Biosafety Clearing-House (BCH) Training Workshop 26-27 September 2014 – Pyeongchang, Republic of Korea

Madam/Sir,

I am pleased to announce that the Secretariat, in collaboration with and support of the "Project for Continued Enhancement of Building Capacity for Effective Participation in the Biosafety Clearing-House" (UNEP-GEF BCH III Project), will convene a "Training and BCH III validation workshop" for National Focal Points for the Biosafety Clearing-House (BCH-NFPs) on 26-27 September 2014, prior to the seventh meeting of the Conference of the Parties serving as the meeting of the Parties to the Cartagena Protocol (COP-MOP 7), in Pyeongchang, Republic of Korea.

The training workshop is being offered <u>exclusively to National Focal Points for the Biosafety</u> <u>Clearing-House (BCH-NFPs)</u>.

With generous financial support from the Government of the Republic of Korea and the support of the UNEP-GEF BCH III Project, limited funds covering travel and Daily Subsistence Allowance (DSA) are available to BCH-NFPs from developing country Parties or Parties with economies in transition who are also accredited as national representatives to attend COP-MOP 7.

Given the limited number of places available for the training, placement for the workshop will be on a *first come first served basis*, in accordance with the date of receipt of a duly completed registration form attached herewith.

Nominations, endorsed by the National Focal Point for the Cartagena Protocol on Biosafety, should be sent to the Secretariat at <u>secretariat@cbd.int</u>, as soon as possible but **not later than 15 August 2014**.

Furthermore, please note that the working languages for the workshop are English, French and Spanish. It is important that nominees indicate their preferred language of training when completing the nomination form.
