Mandate

1. The present questionnaire is circulated in accordance with paragraph 11 of the annex to decision XII/30: "the expert team should design a questionnaire on funding needs for the period July 2018 to June 2022 and circulate it to all Parties to the Convention, and the Secretariat, Independent Evaluation Office and agencies of the Global Environment Facility, and include the results in the assessment report".

Respondents

2. The questionnaire needs to be completed jointly by the National Focal Point of the Convention on Biological Diversity (CBD Focal Point) and the Operational Focal Point of the Global Environment Facility (GEF Focal Point), through a participatory process as appropriate, guided by the national biodiversity committees where applicable.

- Additional funding needs for the period July 2018 to June 2022 arising out of the national implementation of the Strategic Plan for Biodiversity 2011-2020 (paragraph 5(e))
- Compilation and analysis of any supplementary information provided by Parties which are developing countries or countries with economies in transition on their funding needs for the implementation of their obligations under the Convention and its Protocols (paragraph 5(f))"

Workload

5. The estimated time for collecting, compiling, consulting and completing the questionnaire is one to two weeks on average.
