# Briefings by the WG2020 Co-Chairs on the First Draft of the Post-2020 Global Biodiversity Framework

Dear Madam/Sir,

The Secretariat is pleased to announce two information briefings by the Co-Chairs of the Openended Working Group on the First Draft of the Post-2020 Global Biodiversity Framework, to be held on **22 July 2021**. The First Draft (<u>WG2020/3/3</u>) and the document on Digital Sequence Information on Genetic Resources (<u>WG2020/3/4</u>) were released on 12 July 2021.

The briefings are intended to familiarize participants with the First Draft of the Post-2020 Global Biodiversity Framework, its structure and content, and to give the Co-Chairs of the Open-ended Working Group and the Secretariat the possibility to address any questions raised by participants. The briefings will thus provide an important opportunity to update Parties and stakeholders on the details of the First Draft, which will be formally considered at the third meeting of the Open-ended Working Group on the Post-2020 Global Biodiversity Framework (WG2020-3), to be held virtually from 23 August to 3 September 2021.
