On behalf of the NBSAP Accelerator Partnership, I would like to invite Parties to participate in a rapid capacity needs assessment survey intended to provide insights into the existing capacity and resources, the capacity needs and priorities and the challenges faced by Parties in the review, update, implementation and monitoring of their national biodiversity strategies and action plans (NBSAPs).

The survey is being conducted by the interim Global Coordination Unit of the NBSAP Accelerator Partnership, comprising the Secretariat of the Convention on Biological Diversity (CBD), the United Nations Development Programme (UNDP) and the United Nations Environment Programme (UNEP).

Annex A Guidance on the Rapid Capacity Needs Assessment Survey

Background

The NBSAP Accelerator Partnership, initiated by the Governments of Colombia and Germany and launched at COP 15, currently comprises 21 governments and 8 organizations committed to accelerating the implementation of the Kunming-Montreal Global Biodiversity Framework (GBF) through national biodiversity strategies and action plans (NBSAPs). Its aim is to enhance national ambition and political commitment to the NBSAP update, implementation and reporting by facilitating access to financial and technical support through customized incountry facilitation and matchmaking, enabling cross-country learning, raising the political profile of NBSAPs, and promoting collective action for nature-positive development.

The NBSAP Accelerator Partnership is undertaking a survey to gather information on countries' existing capacity, resources, and the capacity needs and priorities for the implementation of the GBF. The results will help to inform and guide the Partnership and other NBSAP supporting initiatives and processes on how to best support Parties' capacity-building efforts and offer tailored support for the effective implementation and monitoring of the GBF.

The survey may take up to 30 minutes. Kindly complete it by no later than 15 September 2023.

System Requirements
