NOTIFICATION

Online global dialogue workshops organized by the Intergovernmental Science-Policy Platform on Biodiversity and Ecosystem Services to promote the use of their products in policymaking

Dear Sir or Madam,

In decision 16/11, the Conference of the Parties encouraged Parties to make use of, as appropriate, the assessments and deliverables of Intergovernmental Science-Policy Platform on Biodiversity and Ecosystem Services (IPBES). In the same decision, the Conference of the Parties requested the Subsidiary Body on Scientific, Technical and Technological Advice to consider the outputs of IPBES in its future meetings.

During the twenty-seventh meeting of the Subsidiary Body on Scientific, Technical and Technological Advice (SBSTTA-27), the Subsidiary Body will consider the thematic assessment report on the underlying causes of biodiversity loss, the determinants of transformative change and options for achieving the 2050 vision for biodiversity ("Transformative Change Assessment") and the thematic assessment report on the interlinkages among biodiversity, water, food and health ("Nexus Assessment"). The pre-session documents related to the findings from these assessments are currently available online in all United Nations languages at: https://www.cbd.int/meetings/SBSTTA-27.

I would like to inform Parties that IPBES will hold online dialogue workshops on each of the above-mentioned assessments in order to provide a space for countries to share experiences regarding the relevance and use of the assessments in specific sectors in developing or revising local, national or regional policies, plans and initiatives.
