For SBSTTA-27 and SB8J-1, the Voluntary Fund is able to support three representatives from Africa, Asia, and Central and South America and the Caribbean, in accordance with the selection criteria outlined in COP decision VIII/5 D Annex, which gives special priority to participants from indigenous peoples and local communities from developing countries and countries with economies in transition and small island developing States, but not excluding applicants in developed countries, and taking into account gender balance to recognize the special role of women from indigenous peoples and local communities.
