#### Overall Characteristics of a "Commitment"

- Regional, global, and trans-boundary (including national?) scope
- Specific and quantifiable commitments with benefits that can be clearly articulated
- Explicitly linked to international obligations
- Involves multiple partners (public and private)
- Championed or at least supported by government(s)

### **Checklist for "Readiness for Launching a Commitment"**

(Suggested criteria for moving GLISPA commitment from step 2 to 3)

✓ Meets all the above characteristics of a Commitment

- ✓ High level public announcement venue set
- ✓ Communication strategy designed
- ✓ High level champion(s) are on board
- ✓ An implementation team is established
- ✓ There is a basic articulation of governance of decision making
- √ A basic implementation plan has been designed
- ✓ Stakeholders have been identified.
- ✓ Benefits to stakeholders have been articulated and owned
- ✓ Some initial funding is committed (quiet campaign phase)

## Caribbean Challenge

**Milestone 1:** By May 2008 (COP-9), GLISPA will support launching of the Caribbean Initiative, including a minimum of 10 Caribbean countries, with focus on sustainable financing of protected areas and implementation of national systems of protected area plans.
