Ladies and gentlemen,

I would like to welcome you all to the Sub-Regional Workshop for Anglophone Africa on the Integration of Climate Change and Ecosystem-based Adaptation in National Biodiversity Planning Processes.

The Conference of the Parties (COP) to the Convention on Biological Diversity (CBD), in decision X/33, requested the Executive Secretary to support Parties to design and implement ecosystem-based approaches for adaptation as they relate to biodiversity.

With you today are participants who are responsible for the development, updating and/or implementation of the National Biodiversity Strategy and Action Plan (NBSAP), as well as participants who are responsible for the development of national climate change adaptation plans. I hope that the workshop will lead to more synergies between the two processes at the national level and more communication and coordination between the different actors.

I wish you all very successful and productive discussions over the coming days and as always the Secretariat stand ready to support your efforts on this issue.
