Global Biodiversity Outlook

The Global Biodiversity Outlook (GBO) series is a periodic report prepared by the Secretariat of the Convention on Biological Diversity. The third edition of the report is one of the main publications released during the 2010 International Year on Biodiversity. While the target audience for the report is policy makers, it is written to be accessible to the general public. The report is available in all six United Nations languages.

The third edition of Global Biodiversity Outlook (GBO-3) presents the status and trends of biodiversity at global, regional and national levels. It analyses the steps being taken by the international community to implement the Convention and to reach the 2010 Biodiversity Target of significantly reducing the current rate of biodiversity loss as a contribution to poverty alleviation and to the benefit of all life on Earth. The report examines the direct and indirect causes of biodiversity loss and the implications of current biodiversity trends for human wellbeing in the future. Possible actions, which can be taken to improve the status of biodiversity and to address the obstacles to the implementation of the Convention, are also presented.

The GBO-3 is based on multiple sources of information. Drawing on more than 100 national reports provided by Parties to the Convention, as well as information provided by the Biodiversity Indicators Partnership (BIP) and scientific articles and assessments, the GBO-3 is an important source of information in the development of the future Strategic Plan of the CBD.
