Please answer here: 请在此处回答： The China Partnership for Business and Biodiversity (CPBB) was officially launched by the Foreign Environmental Cooperation Center (FECO), affiliated with China's Ministry of Ecology and Environment (MEE), in collaboration with business sector, industries, civil society organizations, during the International Day for Biological Diversity Campaign 2022 held in Beijing on May 20, 2022. As an unincorporated, non-profit platform, the CPBB serves as a communication and collaboration network for business sector in China and forms an integral component of the national social action system for biodiversity conservation.



China joined the Global Partnership for Business and Biodiversity (GPBB) of CBD process in February 2015 with FECO designated as the national focal point.

These businesses either are highly depending on biodiversity or has a huge influence on biodiversity.
5. **Expert advisory committee,** individuals provide policy and technical guidance, for the development of CPBB.
6. **Secretariat,** CPBB daily operation and supporting work.
7. **International partners,** the foreign or international intergovernmental and non-governmental organizations who operate in China supporting CPBB's goals
