Note by the Executive Secretary

INTRODUCTION

- 1. In the memorandum of understanding between the Conference of the Parties to the Convention on Biological Diversity and the Council of the Global Environment Facility, it was agreed that the Council would prepare and submit a report for each ordinary meeting of the Conference of the Parties (see decision III/8, annex, para. 3).
- 2. In decision XII/30, paragraph 8(e), the Conference of the Parties invited the Global Environment Facility to "make available a preliminary draft of its report to the Conference of the Parties, particularly focusing on the response of the Global Environment Facility to previous guidance from the Conference of the Parties, to the Subsidiary Body on Implementation prior to the meeting of the Conference of the Parties at which the report will be formally considered, with a view to promoting effective and timely consideration of the information provided in the report". The report of the Council of the Global Environment Facility to the Subsidiary Body on Implementation at its third meeting is being issued as CBD/SBI/3/6/Add.1.
- 3. In addition, the Executive Secretary is circulating herewith a list of projects and programmes approved during the reporting period. The list, which was originally annexed to the report of the Council of the Global Environment Facility, is reproduced, in English, French and Spanish as it was received by the
