Brief description	The Philippine Clearing House Mechanism (CHM) is established to facilitate the sharing of data and information on the conservation and sustainable use of biological diversity between and among the various stakeholders in the country. This is part of the Philippine commitment to the Convention on Biological Diversity (CBD) which created the Clearing House Mechanism pursuant to Article 18.3 of the Convention. The CHM aims to contribute significantly to the implementation of the CBD by promoting and facilitating technical and scientific cooperation among Parties, other Governments and stakeholders. Sharing of information is done through a web-based information system using this website (http://www.chm.ph)

Comments on national situation

1.Philippine CHM:

The Philippine Clearing House Mechanism has been active and supportive in giving technical guidance and expertise in the development of various country reports and action plans. They had been active participants in the crafting of the Philippine Biodiversity Strategy and Action Plan 2015-2028 and are currently invited to attend the workshops for the preparation of the 6th National Report (6NR) to CBD.

In terms of data sharing, more collaborative efforts should be done to encourage partners to upload their data at the Philippine CHM website.

The Philippine CHM should be strengthened by conducting more meetings and capacity building activities.

Comments on national situation

2.Philippine CHM Website

The existing Philippine CHM website which was developed last 2009 needs enhancement. Due to the lack of a webmaster or a technical staff hired specifically for the maintenance of information, it has minimal information and was rarely visited. Biodiversity information was instead posted/published at the official website of the office.

Two options are to be discussed with agency heads on how to enhance the CHM website:

- 1.Design and develop a new CHM website using available CMS; or
- 2. Adopt the Bioland Tool

Since the newly designated webmaster might be busy and might not be able to handle the migration of the existing and posting of new information in the new CHM website that would be agreed upon, funding will be available for hiringIT technical staff for the migrating, posting and updating of the information at the new CHM website.

Comments on roadmap

The overall direction for the roadmap is to have an strengthened national CHM with identified activities and strategies to make it more effective as technical advisers and implementors of our NBSAP. Next is to encourage our partners to provide more effective and accessible information about national biodiversity thru the CHM website. In order to provide accessible information, the enhancement of the CHM website has to be done, proposing functionality of the bioland tool as alternative to other CMS. Funding support for all the proposed activities also needs to be worked out with the financial officers.
