Note by the Executive Secretary

I. INTRODUCTION

- 1. Decision NP-3/6 of the Conference of the Parties serving as the meeting of the Parties to the Nagoya Protocol called for Parties, non-Parties, relevant organizations and other actors to continue to implement awareness-raising activities, and requested the Executive Secretary to continue to seek feedback from Parties, non-Parties and other relevant actors on the access and benefit-sharing awareness-raising toolkit¹ developed by the Secretariat and to provide an update on the implementation of the awareness-raising strategy for the consideration of the Conference of the Parties serving as the meeting of the Parties to the Nagoya Protocol at its fourth meeting.
- 2. In response to this request, an invitation to share information on capacity development and awareness-raising related to the Nagoya Protocol, and to provide feedback on the CEPA Toolkit Including considerations for access and benefit-sharing (CEPA Toolkit), was sent through notification 2021-037 of 17 May 2021. This document presents the responses to the survey sent to collect feedback on the CEPA Toolkit (section A) and updates on measures undertaken since 2019 to implement the awareness-raising strategy (section B). The questions used in the survey can be found in the annex. Twenty-nine responses were received. Key highlights and findings of the survey have been presented in document CBD/NP/MOP/4/5.

II. RESULTS OF THE SURVEY

A. Feedback on the CEPA Toolkit

3. The toolkit on communication, education, and public awareness (CEPA) including considerations for access and benefit-sharing (ABS) was developed by the Secretariat with a view to supporting the implementation of the awareness-raising strategy. The Executive Secretary was requested to seek feedback







Q3. What is your level of satisfaction with the ABS CEPA toolkit?




Q4. Please provide additional information on the reasoning of your response regarding your level of satisfaction (examples from the 20 responses).

- The CEPA toolkit is useful in creating national awareness-raising strategies. However, situations in different parties are extremely varied. The toolkit provides guidelines and solutions that refer to almost ideal situation which is not a reality in majority of countries (lack of human, technical and financial resources)
- This is one important tool that can better improve the capacity of agencies in developing related ABS awareness raising materials wherein message can be clearly conveyed and understood in a simple and not so scientific manner.
- We need culturally appropriate tools and materials for IPLCs
- The ABS CEPA Toolkit excellently provides substantive and reliable strategies and models for effectively communicating ABS vis-à-vis biodiversity-related issues at the national level. Furthermore, it functions as a one-stop shop for wide range of education and communication interventions as it enables the national focal points and relevant stakeholders to be flexible and open to the best solutions to create bespoke communication, education and public awareness activities based on the status of ABS implementation in their own countries.
- It covers three broad areas of Communication, Education and Public Awareness very well. The language used in the toolkit is simple and understandable by various literacy levels. The toolkit also includes useful information in a form of "Recommended resources, Tips and Practical Tools"



 - The main challenges are lack of financial and human resources to implement the awareness raising strategies
 - Access and benefit sharing concepts are not easy to communicate
 - ABS is an emerging issue in many countries and key stakeholders have limited understanding of the issues
 - Nagoya Protocol is not a priority for many authorities

 - Develop your awareness raising strategies/materials fitted on the country's context. Be real, simple

 - Put your efforts on key players (not massive or general public). When some type of regulation is achieved, the sectors begin to want to comply and commit, and then you put your efforts into the general public.
 - A variety of communication, education and public awareness approaches is crucial to meet the needs of all stakeholder groupings.
 - Attend the local needs, work using inclusive methodologies taking in consideration the orality and the IPs human rights.
