

City Airport Train – CAT

The CAT (City Airport Train) is a direct connection between Vienna Airport and the city centre with city check-in facilities. You can check in and obtain your boarding card at Wien-Mitte train station up to 24 hours prior to your departure (service not available for all carriers, you will find the complete list at <u>www.cityairporttrain.com</u>).

City Air Terminal: Wien Mitte

Travelling time: 16 minutes non-stop Departures: every half hour Price: 12 € single, 21 € return

Tickets can be booked and printed out directly on the CAT homepage <u>www.cityairporttrain.com</u>, or purchased from ticket vending machines or from the conductors on the train.

Train:

S7 railway line or the Railjet

The S7 railway line takes 25 minutes, and runs at 30-minute intervals, between Wien Mitte and the airport (with regular stops on the way).

Railjet (direction from/to Graz or Salzburg)

The Railjet to/from Graz or Salzburg takes 25 minutes, and runs hourly between Wien Hauptbahnhof (Vienna Main Station) and the airport.

Tickets: $4.80 \notin$ for a single ride.

Vienna Airportlines bus service

From Westbahnhof, Südbahnhof, Center (Morzinplatz/Schwedenplatz) to Vienna Airport

Service daily from 5.00 am -0.20 am, approx. every 30 minutes, duration of trip approx. 20 minutes to Centre and 40 min to the train stations One-way ticket: $8 \in$ (all tickets include 3 pieces of luggage) The bus stop at Vienna International Airport is located directly in front of the arrivals and departures hall.

Taxi service:

Approximate price: $40 \notin$ Approximate duration: 30–45 minutes Radio taxis are entitled to ask for an additional return trip fee of $10 \notin$ to the airport.

The currency in Austria is the Euro (\in). The current exchange rate as at 16 October is US 1 = 0.9028 and $\in 1 = US$ 1.10757. Currency exchange facilities are readily available in banks and hotels
