#### 1. Opening and registration

The third Coordination meeting for Governments and Organizations implementing and/or funding Biosafety Capacity-Building activities and the fourth meeting of the Liaison Group on Capacity-Building for Biosafety will be held back-to-back in Lusaka, Zambia, from 26–28 February and 1-2 March 2007, respectively.

#### 1.1 Coordination meeting

The meeting will be opened will be on Monday, 26 February 2007 at 9 a.m. and registration will take place at the meeting venue at 8.30 a.m. the same day.

#### 6. Arrival at Lusaka International Airport (LUN/FLLS)

The city of Lusaka is serviced by the Lusaka International Airport (LUN/FLLS), which is about 14 km from the meeting venue. The hotel has a shuttle bus service from the airport at a cost of US \$ 10. The cost of a taxi is about US\$ 20.

#### 8. Currency and rate of exchange

Zambia's currency is the Zambian kwacha (ZMK). The current exchange rate ( January 2007) is 1 US = 4,200 ZMK or 1 ZMK = 0,024 US\$

#### 9. Credit Cards

Major credit cards (Visa, MasterCard) are accepted in most hotels and restaurants.

#### 10. Time zone

Zambia time in February & March will be GMT/UTC + 2 hours

#### 11. Weather conditions


#### 12. Voltage

Electricity in Zambia is 230 Volts, alternating at 50 cycles per second. If you travel with a device that does not accept 230 Volts at 50 Hertz, you will need a voltage converter.

Plug Adapters and Outlet Shapes are shown below. Outlets in Zambia generally accept 3 types of plug:









Three round pins arranged in a triangle



Two parallel flat pins with ground pin

If your appliances plug has a different shape, you may need a plug adapter.
