5. General information on access to Ljubljana, Slovenia



At the time of the meeting Ljubljana, Slovenia will be serviced by the Trieste Airport - Aeroporto Friuli-Venezia Giulia, in Trieste, Italy, as the main airport in the capital city of Slovenia will be closed for renovations. The Trieste airport is located about 122 kilometres from Ljubljana's city centre.

Bus transfer from Trieste airport to hotels in Ljubljana, Slovenia has been provided by the Government of Slovenia for <u>all participants</u> on 16 April 2010 at 11:30 P.M. Also, the return trip to Trieste airport will depart on 23 April 2010 at 7:00 P.M.

6. Visa information



Participants certain countries require a Schengen visa for Slovenia and are strongly advised to contact the nearest Slovenian diplomatic or consular mission **as soon as possible** in order to secure the required entry visa in a timely manner, prior to departure. Please note that airlines will not allow boarding without a valid visa.

The currency in Slovenia is the Euro (\in). The current exchange rate as at 2 March 2010 is US $\$1 = \notin 0.74$ and $\notin 1 = US \$1.35$.
