

# 5. General information on access to Ljubljana, Slovenia



Ljubljana is be serviced by the Ljubljana International Airport which is approximately 21 km outside the city centre.

#### Taxi

Taxis are available outside the baggage claim area of the airport and transportation to Ljubljana City costs approximately €39 and takes about 35 minutes.

There is a bus available to and from the airport to Ljubljana at a cost of €4,10 and the journey takes approximately 45 minutes. Details are listed below.

# 6. Visa information

The currency in Slovenia is the Euro ( $\in$ ). The current exchange rate as at 9 March 2011 is US  $\$1 = \notin 0.72$  and  $\notin 1 = US \$1.39$ .
