Introduction

The meeting of the Informal Advisory Committee to the Clearing-house Mechanism of the Convention on Biological Diversity will be held on Sunday, 6 February 2005, in Bangkok, Malaysia.

The draft provisional agenda prepared by the Executive Secretary (UNEP/CBD/CHM) addresses proposals contained in document UNEP/CBD/COP/7/INF/12, *Results of the independent review of the Clearing-House Mechanism of the Convention on Biological Diversity.* It also addresses all other issues referred to in: Decision VII/23, scientific and technical cooperation and the Clearing-House Mechanism, and decision VII/29, transfer of technology and technology cooperation,. The meeting may wish to adopt the agenda with such amendments as may be agreed upon.

<u>Item 3.Discussion on implementation of items related to decision VII/23: Scientific and technical cooperation and the Clearing-House Mechanism</u>

- 5. Under this item, participants will be invited to consider activities to implement items related to the independent review of the clearing-house mechanism of the Convention on Biological Diversity (UNEP/CBD/COP/7/INF/12) and recommendations from the Asia and Pacific regional meeting on the Clearing-House Mechanism, held in Bangkok, Thailand form 3 to 5 February 2004. Participants are also welcomed to comment on the use of the IAC Collaborative Portal which was established to facilitate work by the IAC.
- 6. Participants may also propose and discuss additional issues not necessarily anticipated by the Secretariat.
- 7. The meeting will consider items related to decision VII/23, including:

Paragraph 6: Requests the Executive Secretary to use the clearing-house mechanism, in collaboration with the informal advisory committee, to continue to strengthen collaboration with international partners and organizations for review at the eighth meeting of the Conference of the Parties and to report on that collaboration, including an elaboration of the relative roles of the clearing-house mechanism and information facilities dealing in particular with taxonomic databases including, IABIN (Inter-American Biodiversity Information Network) hubs, BioNet LOOPs (Locally Owned and Operated Partnerships), NatureServe CDCs (Centres for Data Conservation), nodes of the Global Biodiversity Information Facility and Species 2000 and the Integrated Taxonomic Information System's Catalogue of Life;	The Integrated Taxonomic Information System and Species 2000 participated in the Informal meeting on interoperability of information among the three Rio and other environmental conventions, held in Montreal, November 2004. The CHM joined the Global Biodiversity Information Facility expect group on information and communication technologies.
Paragrapah 7, items a-g: <i>Also requests</i> the Executive Secretary to:	

(a)Update the strategic plan of the clearing-house mechanism to 2009, in collaboration with the informal advisory committee, for consideration by the eighth meeting of the Conference of the Parties;	(a) Work on updating the strategic plan is ongoing. A section on the IAC Collaborative Portal was created for this item.
(b) Convene, subject to the availability of financial resources, regional workshops as a catalysing mechanism to allow for the interaction of international thematic focal points with the national focal points to further enhance the scientific and technical cooperation goal of the clearing-house mechanism and to build capacities at the national level with regard to use of and access to new information technologies;	(b) The Asia and Pacific regional meeting on the Clearing-House Mechanism was held in Bangkok, Thailand from 3-5 February 2005. A GRULAC regional meeting is planned for March 2005.
(c) Update the clearing-house mechanism toolkit to be used as a meta-toolkit, linking the different existing toolkits with a view to optimize their resources and assist users to choose the most appropriate technology;	(c) Work on updating the CHM toolkit is ongoing. A section on the IAC Collaborative Portal was created for this item.
(d) Examine ways to develop regional portals to visualize and exchange national and regional cartographic information (geographic information systems and remote-sensing) from all thematic areas (including maps, satellite images and datasets);	(d) The informal meeting on interoperability of information among the three Rio and other environmental conventions, held in Montreal, from 2-3 November 2004, discussed this item. Recommendations are available in document UNEP/CBD/CHM/IM-Interop/1/2
(e) Advise on ways the clearing-house mechanism can assist to make relevant information interoperable among the three Rio conventions for review at the eighth meeting of the Conference of the Parties	(e) An informal meeting on interoperability of information among the three Rio and other environmental conventions was held. A working plan was agreed upon, and recommendations arising from the meeting are available in document UNEP/CBD/CHM/IM-Interop/1/2
(f) Develop an Internet-based web portal on island biological diversity to integrate, into the existing clearing-house mechanism, information on relevant programmes or initiatives such as the Small Island Developing States Network (SIDsnet), the Coastal Regions and Small Islands-UNESCO, the Small Islands Voice and the small island developing states activities programme of the United Nations Environment Programme;	(f) The portal is under development and should be completed before February 2005.
(g) Further enhance the sections on the Convention's website related to the programme areas and crosscutting issues, by applying the lessons learned from the development of the Biosafety Clearing-House, especially its use of common formats, protocols and standards, to increase interoperability of data and information	(g) The entire Convention website was re-designed and the infrastructure improved to facilitate the searching, locating and retrieving of information.

Paragraph 8: Calls on the Informal Advisory Committee to assess the results of the independent review of the clearing-house mechanism of the Convention Biological Diversity on (UNEP/CBD/COP/7/INF/12) and assist Executive Secretary on measures and actions to be undertaken to strengthen the clearing-house mechanism's role in promoting technical and scientific cooperation, including its role in facilitating the transfer of technology and knowand capacity-building to support implementation of the Convention at the national level.

A section on the IAC Collaborative portal was created to assist the IAC in this task. The CHM will compile comments made for presentation during the meeting.
