#### Comments on national situation

There is overwhelming support for the creation of a national clearing house mechanism for biodiversity in Palau. In fact Palau recognizes that in order for it to effectively implement its NBSAP it needs to collect, house and manage data better than it is currently doing. A GEF funded project is being implemented to ensure that the enabling framework and capacities that is needed to achieve this is in place. Aligning the development of Palau's CHM with this parallel process is an efficient way to optimize resources in support of mutual objectives.

#### Comments on national situation

Previously the limiting factor to putting together a CHM for Palau was the high technological requirements, the perceived cost of that technology, and a general lack of understanding about how to begin developing a clearing house portal. Fortunately, what seemed like substantial roadblocks are turning out to be surmountable with the Bioland tool.

I will be advocating the use of Bioland in the development of Palau's CHM. I think that this tool will allow the folks at MNRET to be able to manage and update the content so that portal is truly relevant to our NBSAP implementation.

### Cooperation opportunities / Type of support needed

I think that the Bioland tool is user friendly and should be relatively easy for a skilled technician to understand it and teach it to others. If the Secretariat provides remote support for users it would make using this tool that much more attractive and accessible.
