NAPA	National Agency on Protected Areas	Their role is to manage the PA, to survey and to monitor within the PA. They are the competent authority to develop and implement the Management Plan for the PAs
NEA	National Environment Agency	Their main role is the monitoring of the indicators for, water, air, soil, biodiversity.
FNS	Faculty of Nature Science	Study the component of nature like flora and fauna. Make publications on nature situation and studies cared out, etc.
NIEF	National Inspectorate of Environment and Forests	The main duty is the law implementation
NANR	National Agency of Nature Resources	Their main duty is to protect and adminiser national interest on hydrocarbons, minerals and energy.
NATP	National Agency of Territory Planning	One of the main duties is to examine the conformity of the application for development or undergoing development with the provisions of binding instruments such as planning, building regulations, environmental conditions, sustainability, protection of natural and cultural heritage and other conditions specifically laid down by the Law on Territorial Planning.

#### **Comments on national situation**

Albania had a CHM page in the period 2003-2005 in the frame of a EEA initiative. The page was not maintained and updated after a couple of years due to a lack of human and financial resources. Therefore it was frozen and is no longer active.

Until the NBSAP revision project started, the major challenge was the lack of financing to open and maintain a webpage. Lack of experience on setting-up such kind of web page was another limiting factor.

The financing issue is resolved for the design phase by the project. The maintenance will be covered by the Biodiversity and Protected Areas Directorate in cooperation with the IT unit at the MoE. A small budget for the page to be kept updated will be planned in the medium term budget starting from 2017 (PBA).

#### Strategic Vision

The national CHM will support the NBSAP implementation, by providing the up to date information on biodiversity in Albania and by providing an easy access to the legal framework, biodiversity database (BIONA), the Protected areas portal etc.
