Comments on national situation

During last decade several steps were made towards the creation of CHM prerequisites, some work was done, but there was no progress in the following years. Country currently has no CHM.

Strategic Vision

The establishment of the national CHM portal as a network promotes scientific and technical cooperation between institutions, organizations and individuals involved in the research or the protection of biodiversity. It will be a basis for better coordination, information sharing and technology transfer, as well as exchanging the national information between stakeholders which will contribute to the implementation of obligations of the Convention.

- Designation of the national focal point for the CHM
- Identification of the national structure to coordinate the development of the CHM with participation of a relevant biodiversity-related organization and stakeholders
- Preparation of the realistic national implementation strategy for the CHM
- Improvement of the technical capacities: capacity building and technical equipping of organizations
- Development of the information exchange mechanism with relevant national sources of biodiversity information.

Comments on roadmap

Taking into account that country currently has no CHM, and for the establishment of CHM it is a very important issue to have a Focal Point which will coordinate these works. Appointment of Focal Point will create an opportunity to collaborate with stakeholders and other related biodiversity organizations. It is very important to have a support and cooperation in creation of CHM website.

Cooperation opportunities / Type of support needed

- Provide guidance to the Country on how to develop their national clearing-house mechanisms, taking into account a variety of implementation options
- Organize capacity-building workshops to assist Country in developing national clearing-house mechanisms, including through partner organizations at the national or regional levels, and based on the special capacity-building needs of the country and on the status of the national clearing-house mechanisms.
