CHM for BiH was established within the UNEP/GEF project. A CHM NFP has not been nominated yet. It is available in 4 languages (Bosnian, Croatian, Serbian and English). The CHM BiH currently provides information on status of biological diversity in BiH, brief review on CBD and the Strategic Plan with Aichi Targets, relevant documents related to biodiversity that exists in BiH, regional cooperation on biodiversity, institutional and legislative framework regarding biodiversity conservation, photos of biodiversity in BiH, important global environmental/biodiversity dates, relevant links, etc.

CHM for BiH has not been regularly updated – it has not been updated since the February 2015.
