
Madam/Sir,

I have the honour to refer to the fifth meeting of the Conference of the Parties to the Convention on Biological Diversity scheduled to take place in Nairobi, Kenya, from 15-26 May 2000.

In this regard, I am pleased to inform you that there is a possibility to organize regional meetings on Saturday and Sunday, 13 and 14 May 2000 in Nairobi, Kenya to assist developing countries party to the Convention to review and exchange views regarding the various topics that will be discussed during COP V. Therefore, please advise if your officially designated Government representative, eligible for funding support, will be able to participate in these meetings. This information is **urgently** needed in order to allow the Secretariat to issue the air ticket accordingly.

I would also like to remind you that the Cartagena Protocol on Biosafety shall be open for signature at COP V.
