SUBREGIONAL CAPACITY-BUILDING WORKSHOP ON FINANCIAL REPORTING AND RESOURCE MOBILIZATION FOR EASTERN EUROPEAN AND CENTRAL AND WEST ASIAN COUNTRIES Tbilisi, Georgia, 25-26 February 2016

### BACKGROUND AND PROGRAMME OF WORK

#### I. BACKGROUND OF THE WORKSHOP

- 1. In decision XII/3, on resource mobilization, the Conference of the Parties to the Convention on Biological Diversity adopted five targets for resource mobilization (para. 1) as well as a revised Financial Reporting Framework (paras. 14 and 24), and invited parties and other Governments to report thereon, using online reporting systems, where feasible, by 31 December 2015. It also requested the Executive Secretary to organize workshops, in cooperation with relevant organizations and initiatives, with a view to catalysing and supporting the provision of technical guidance and capacity-building on financial reporting, the identification of funding needs, gaps, and priorities, and the development of national resource mobilization strategies, and, in line with the programme of work on incentive measures, on the implementation of the milestones for the full operationalization of Aichi Biodiversity Target 3 (para. 32(a)).
- 2. The subregional capacity-building workshop on financial reporting and resource mobilization for Eastern European and Central and West Asian countries is part of a series of capacity-building workshops and webinars, organized by the Secretariat of the Convention pursuant to the request of the Conference of the Parties above, and with financial support provided by the European Union and the Government of Japan. The workshop will be hosted by the Government of Georgia.
- 3. The objective of the workshop is to enhance the capacity of participants to apply methodologies, frameworks and tools for financial reporting and the development of national finance plans, by sharing and reviewing experiences in applying such methodologies, frameworks and tools; and by providing voluntary guidance thereon, based on the report of the international technical expert workshop on this topic, which was held in Mexico City on 5-7 May 2015.
- 4. The workshop was preceded by a webinar providing a succinct introduction to the Financial Reporting Framework, on 16 February 2016 for the one in English and on 17 February 2016 for the one in Russian. The necessary technical information was communicated to the workshop participants.
- 5. The international technical expert workshop mentioned above highlighted the importance of building on existing reporting processes and associated datasets, both internationally and nationally, for completion of the financial reporting framework. One of the targets for resource mobilization adopted by the Conference of the Parties calls upon Parties to report domestic biodiversity expenditures, as well as funding needs, gaps and priorities, by 2015. In the context of quantifying and reporting domestic biodiversity expenditures, specific reference was made by the workshop to the Classification of

Environmental Protection Activities (CEPA) and its integration in reporting frameworks such as the System of Economic and Environmental Accounting (SEEA), which was recently adopted as an international statistical standard by the United Nations Statistics Commission, or the Classification of the Functions of Government (COFOG) and the associated regional or international reporting thereon.

- 6. In the light of the above, Governments of countries in the subregion were invited to nominate two experts to participate in the workshop: one expert responsible for the implementation of the Convention, in particular for resource mobilization and/or the development of national resource mobilization strategies for the implementation of revised national biodiversity strategy and action plans, and one expert from the national statistical department, or similar agency, working on identifying and compiling statistical information on environmental or biodiversity-related expenditures. The following countries were invited to nominate participants: Afghanistan, Albania, Armenia, Azerbaijan, Bahrain, Belarus, Bosnia and Herzegovina, Georgia, Iran, Iraq, Jordan, Kazakhstan, Kuwait, Kyrgyzstan, Lebanon, Former Yugoslav Republic of Macedonia, Moldova, Montenegro, Oman, Palestine, Qatar, Russian Federation, Saudi Arabia, Syrian Arab Republic, Serbia, Tajikistan, Turkmenistan, Turkey, United Arab Emirates, Ukraine, Uzbekistan and Yemen.
- 7. A logistics note for participants was made available under <a href="https://www.cbd.int/doc/?meeting=RMWS-2016-01">https://www.cbd.int/doc/?meeting=RMWS-2016-01</a>. The languages of the workshop will be English and Russian.
- 8. Sharing national information, in particular practical experiences and good practices, will be a critical contribution towards the success of the workshop. With this in mind, the workshop format features a mix of presentations with question and answer sessions to introduce relevant concepts, tools and mechanisms; discussions to assess the applicability of these concepts, tools and mechanisms in the sub-regional context; and work in break out groups in order deepen understanding and further advance the possible application of these concepts, tools, and mechanisms.
- 9. In preparing for the workshop, participants are encouraged to review their country's fifth national report and the current state of review of the national biodiversity strategy and action plan, and of national resource mobilization plans. In particular, in the light of the individual questions in the Financial Reporting Framework, participants may wish to consider the following areas: (a) valuation and inclusion of biodiversity into national priorities or development plans; (b) identifying and assessing biodiversity-related (public and private) domestic expenditures; (c) identifying and assessing funding needs, gaps and priorities; (d) the mobilization of financial resources for biodiversity from various sources, and the development of national finance plans for biodiversity.
- 10. The registration of participants will commence at 8:30 A.M., on Monday 25 February 2016, at the Holiday Inn Tbilisi, Georgia.
