Stakeholder consultation



Obstacles to applying Safeguards	Not tested and hence not known
Concrete Capacity needs	No capacity needs assessment has been done







National experience with biodiversity safeguards: Potential Capacity Needs

ASPECT	Potential Concrete Capacity Needs
Integration of Biodiversity Safeguards with the REDD- plus Strategy	 Compatibility assessment; Coordination capacity between REDD-plus and Biodiversity agencies Actual assessment of the safeguard requirements Technical and financial capacity including MRV for meeting these requirements
Revising National Biodiversity and Action Plan to Cater for the REDD-plus Needs	 Capacity for Integrating REDD-plus safeguards in NBSAP; Capacity for revising individual agency based Biodiversity plans (Forestry, Wetlands, Wildlife, Agriculture, Below ground, etc) to integrate REDD-plus safeguards that are relevant to Biodiversity
Awareness and Communication	 Preparation and application of an awareness and communication strategy
Governance	All aspects with emphasis to law enforcement
