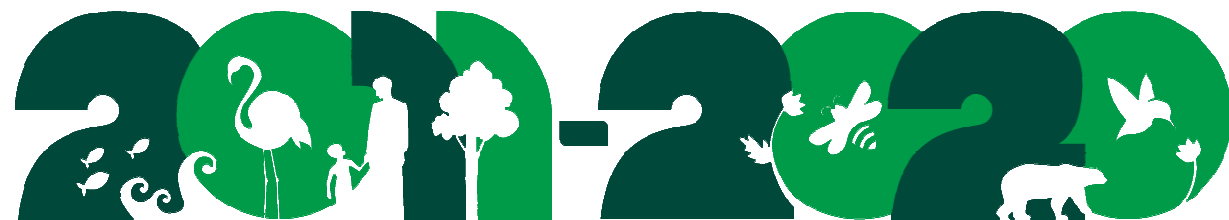

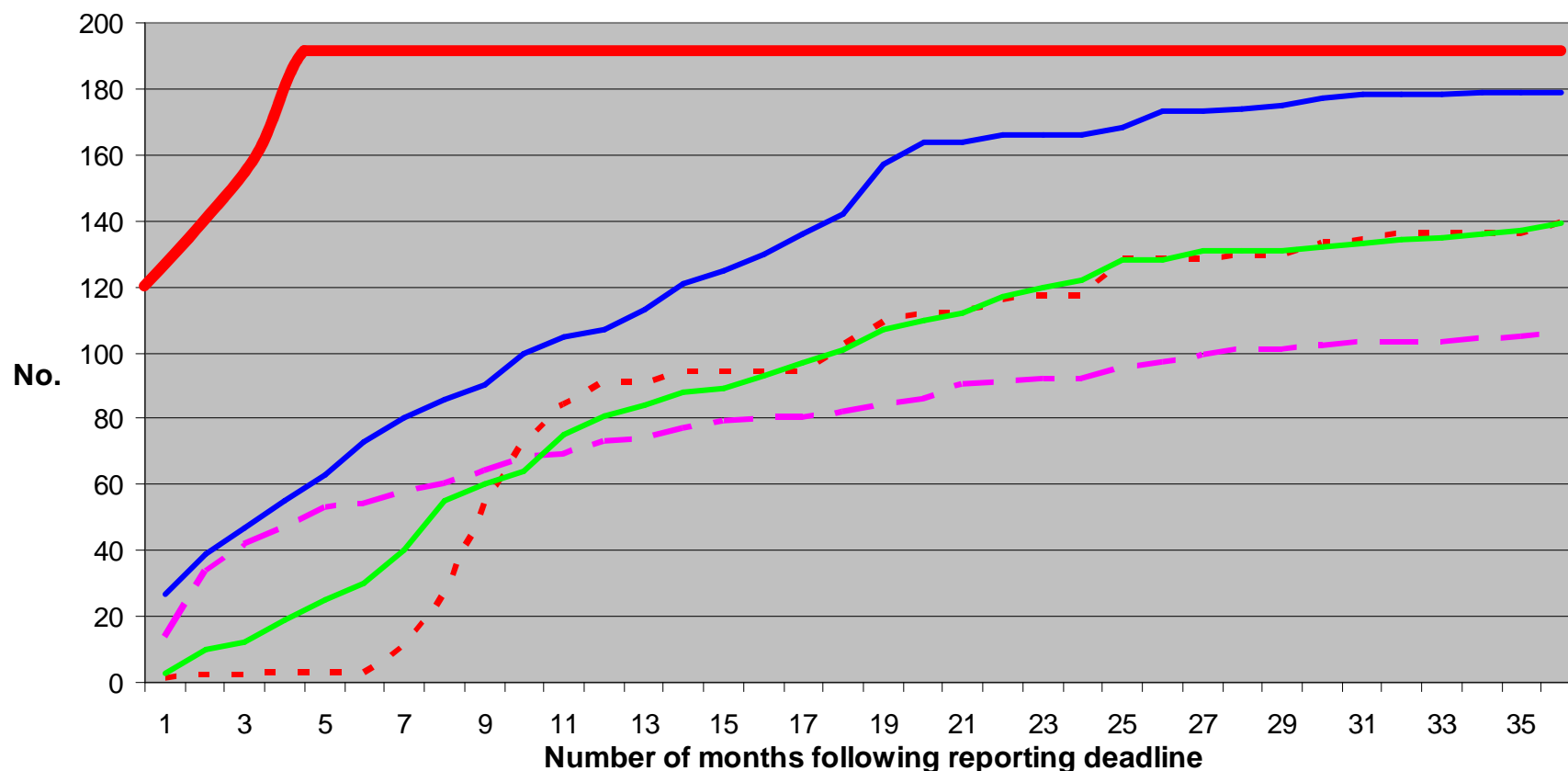
United Nations Decade on Biodiversity

Submission of the Fourth National Report

Historically high level of submissions:

- 26 reports received by the deadline;
- 165 reports received by COP 10 (October 2010)
- 173 reports and 10 draft reports received by COP 11 (October 2012)
- A few countries (Iraq, Somalia, Timor-Leste, etc) submitted their national report for the first time.

Trends in the Submission of National Reports



Number of reports received to date (20 March 2013):

NR1 [- -] - TOTAL TO DATE = 153

NR2 [- -] - TOTAL TO DATE = 135

NR3 - TOTAL TO DATE = 152

NR4 - DTOTAL TO DATE = 181 (174 final, 7 substantial draft)

Factors Contributing to Success

- Stronger political will of Parties
- Change in format to allow more flexibility
- Supporting materials and tools
- Capacity development workshops
- Easy access to and release of GEF funds
- Support from partners (IUCN Countdown 2010; GBIF, Birdlife International, regional and sub-regional organizations)

Lessons Learned

Despite record-level of submissions many countries submitted several months after the deadline:

- Late initiation of the preparation process
- Underestimate of the time required for internal consultation and approval
- Capacity development activities mostly organized after the deadline
- Delays in receiving funding

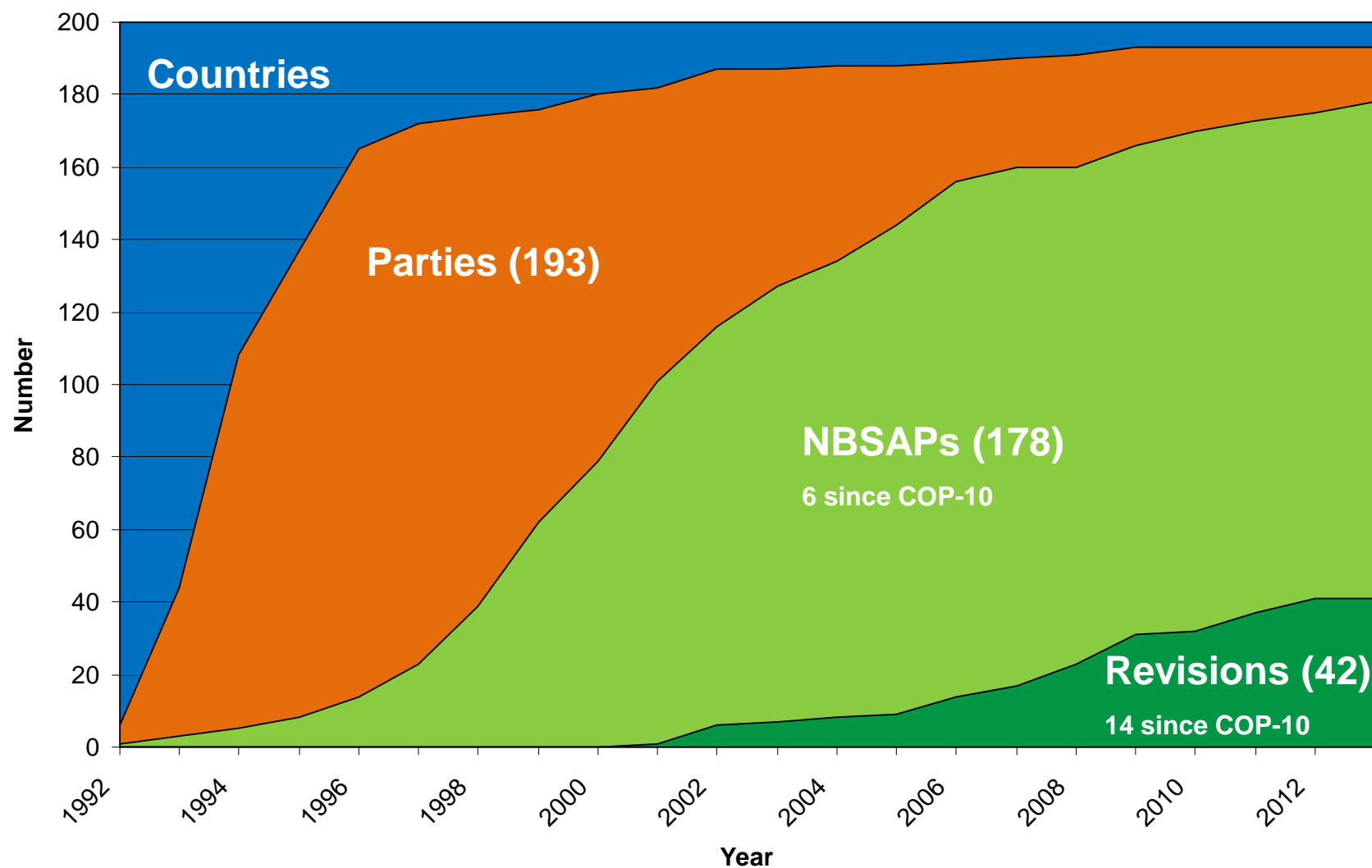
Lessons Learned

- Greater amount and variety of information in the 4NR
- Good treatment of the state of biodiversity but limited information on trends
- Information repeated from previous national reports
- Limited use of indicators
- Information mostly drawn from environment sector
- Lots of description but limited amount of analysis
- Few case studies to illustrate outcomes or impacts
- Sections not balanced

Lessons Learned

- Need for early planning, initiation and coordination
- Greater involvement of stakeholders and experts
- Need to draw on information outside the environment ministry
- Opportunity to prepare the 5NR as a part of the process of updating NBSAP

Global Status of Updating National Biodiversity Strategies and Action Plans

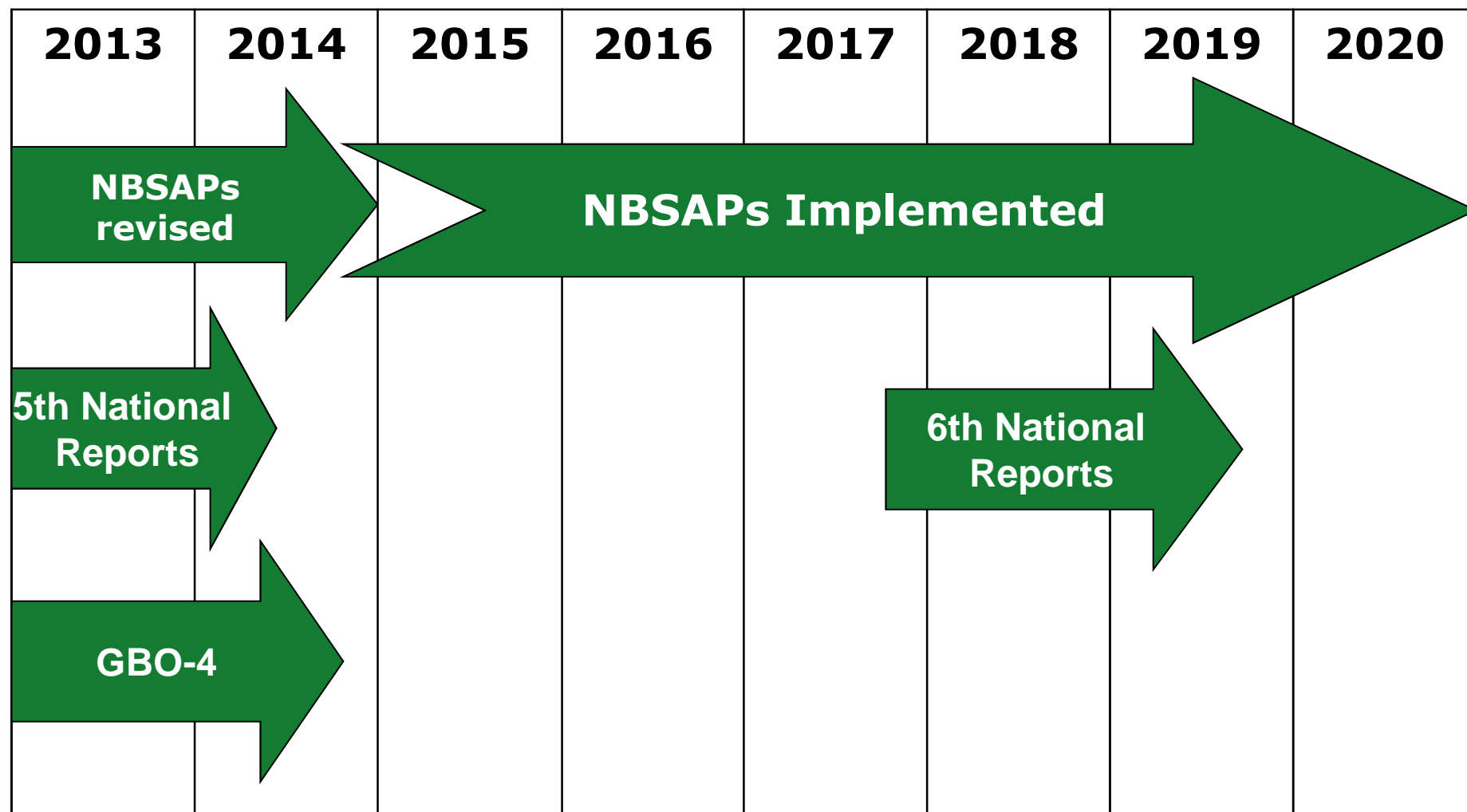


Mandate for Updating NBSAPs

COP10 has urged Parties to :

- **Develop national and regional targets**, using the Strategic Plan and its Aichi Targets, as a flexible framework, in accordance with national priorities and capacities by 2012
- **Review, and as appropriate update and revise, NBSAPs**, in line with the Strategic Plan and decision IX/9, and adopt as a policy instrument, and report thereon to the COP 11 or 12
- **Use NBSAPs as effective instruments for the integration of biodiversity targets** into national development and poverty reduction policies and strategies
- **Monitor and review** the implementation of NBSAPs and report to the COP through their 5th and 6th national reports
